### **Recommendation**

Staff recommends the Governing Board adopt Resolution No. 879 amending the Fiscal Year 2019-2020 budget and allow staff to realign revenues and reserves to maintain the proper balance in each fund.

### **Background**

District procedures allow for budget amendments to occur within 60 days following the end of a fiscal year (FY). Based on expenditures paid that count toward the FY 2019-2020 budget, several changes are requested to properly align budget with these costs. Amendment No. 17 realigns budget categories of Salaries and Benefits (S&B), Contracted Services, and Operating Expenses within and across funds, activities, and projects. This amendment does not increase or decrease the total District budget.

Budget realignments include:

- 1. \$116,520 in Personnel Budget:
  - a. \$58,040 in S&B related to Other Water Resources Planning (OWRP). Budget is moving from Activity 130 Technical Assistance to Activity 113 OWRP.
  - b. \$58,000 in S&B related to Minimum Flows and Minimum Water Levels. Budget is moving from Activities 120 Research, Data Collection, Analysis and Monitoring (\$20,000) and 150 Technology and Information (\$38,000).

- c. \$400 in S&B related to Surface Water Projects. Budget is moving from Activity 270 Technology and Information Services to Activity 230 Surface Water Projects.
- d. \$80 in Other Personal Services S&B for Research Data Collection Compensated Absences. Budget is moving from Activity 150 Technology and Information Services to Activity 120 Research, Data Collection, Analysis and Monitoring.
- 2. \$1,470 in Contracted Services for legal services related to the Governing Board. Budget is being transferred from Operating Expenses within Activity 611 Executive Direction.

#### **Recommendation:**

Staff recommends the Governing Board (1) determine that its interest in 11,342 square feet is not required for the District's purposes (pursuant to Section 373.056(4), Florida Statutes), (2) donate the requested interest in the 11,342 square feet to FDOT and (3) not reserve any interest in the property's phosphate, minerals, metals, and petroleum rights, pursuant to Section 270.11(1), Florida Statutes.

#### Background:

The FDOT is requesting the conveyance of 11,342 square feet of District property located in Santa Rosa County (see attached map) to FDOT. The requested land will be used for the public purpose of U.S. Highway 90 Road Improvements - Bridge Replacement in the Escambia River WMA between Pace and Pensacola. This District land was part of the 1984 purchase from St. Regis/The Nature Conservancy. The District owns an undivided one-half interest in this property and Charlene Holler owns an undivided one-half interest in this property. According to FDOT staff, Charlene Holler, has agreed to donate her onehalf interest in this parcel.

FDOT appraisal staff indicated that land of this nature would typically value at one and a half cents a square foot due to its specialty or limited use. For the land being requested, this equates to around \$170.13.

### **Recommendation:**

Staff recommends the Governing Board authorize the Executive Director to execute a Contractual Services Agreement with the Florida Department of Agriculture and Consumer Services to receive funding for prescribed fire enhancement, subject to approval of a Fiscal Year 2020-2021 budget amendment and administrative and legal review.

#### **Background:**

The Florida Legislature allocated funds for the enhancement and implementation of Florida's Prescribed Burning Program on public conservation lands to reduce dangerous wildland fuel loading in high priority areas across Florida for fiscal year 2020-2021. The Florida Forest Service (FFS), a division of Florida Department of Agriculture and Consumer Services, was tasked with working with state agencies to develop projects that will increase prescribed burning capacity and increase the amount of acres that are burned. The intent of the program is to reduce the threat of wildfire while also increasing forest and ecosystem health.

The FFS, for FY 2020-2021, has awarded the District \$21,000 to help reduce the prescribed fire backlog. The funding will be used for contractual services, including activities such as helicopter services to support the District's aerial ignition burns, fireline plowing, and dozer/plow standby services during certain prescribed burns implemented by District staff.

Staff recommends the Governing Board approve the bids submitted in response to ITB 20B-001 for 2021 Hand Planting Services for Reforestation and Groundcover Restoration and authorize the Executive Director to execute an agreement with the low bidder, Amigo Forestry Service, Inc. in the amount of \$60,064.14 to facilitate this work.

### **Background**

On October 20, 2021, the District issued an Invitation to Bid for services associated with our ongoing reforestation and wetland mitigation programs on District lands. The 2021 services will entail hand planting 699,864 longleaf pine tubelings, 46,000 slash pine tubelings, and 275,000 groundcover plant tubelings in Bay, Calhoun, Escambia, and Washington counties in the Chipola River, and Econfina Creek water management areas (WMAs) and on the Sand Hill Lakes Mitigation Bank and the Ward Creek and Dutex Wetland Mitigation tracts (see attached General Location Maps). The services required of the contractor are outlined below:

### **Longleaf Pine Reforestation**

The District will be planting 699,864 longleaf pine tubelings on 964 acres of disturbed natural longleaf pine habitat at a stocking rate of 726 tubelings per acre. This will occur in the Chipola River and Econfina Creek WMAs.

### **Slash Pine Reforestation**

The District will be planting 46,000 slash pine tubelings on 63 acres of disturbed natural slash pine habitat at a stocking rate of 726 tubelings per acre. This will occur on the Chipola River WMA, Altha Tract.

### **Groundcover Restoration**

The District will be planting 275,000 groundcover plant tubelings (wiregrass, toothache grass, and other mixed native grasses) on 82 acres of wetland and upland sites that are undergoing restoration for wetland mitigation purposes. These will be planted at stocking rates of 1,210 tubelings per acre and 4,840 tubelings per acre. The groundcover restoration will occur on three wetland mitigation sites: the Ward Creek tract in Bay County, the Sand Hill Lakes Mitigation Bank in Washington County, and the Dutex tract in Escambia County.

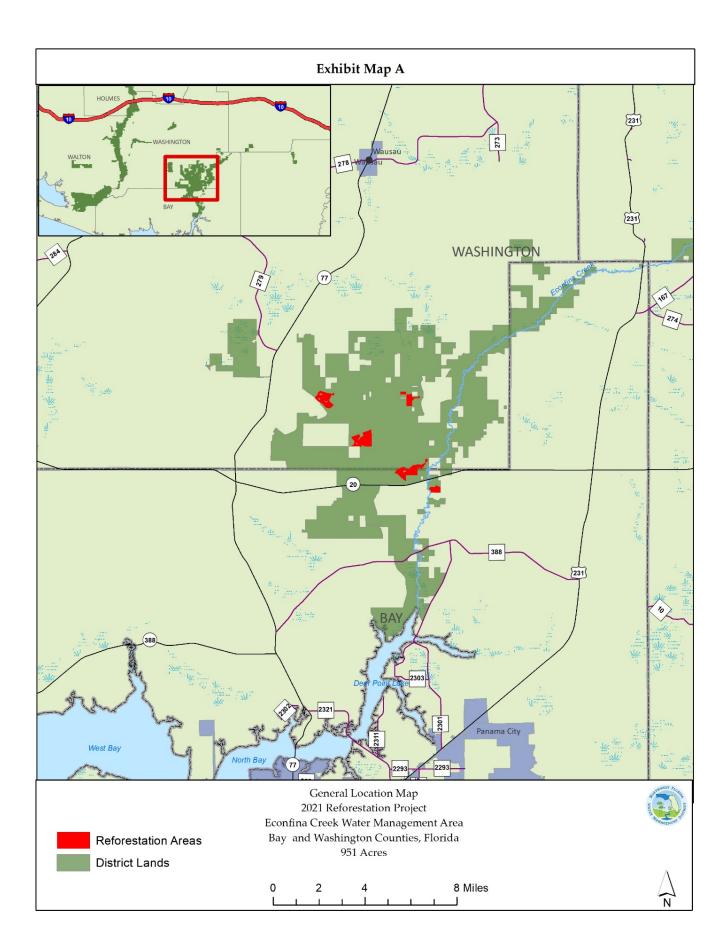

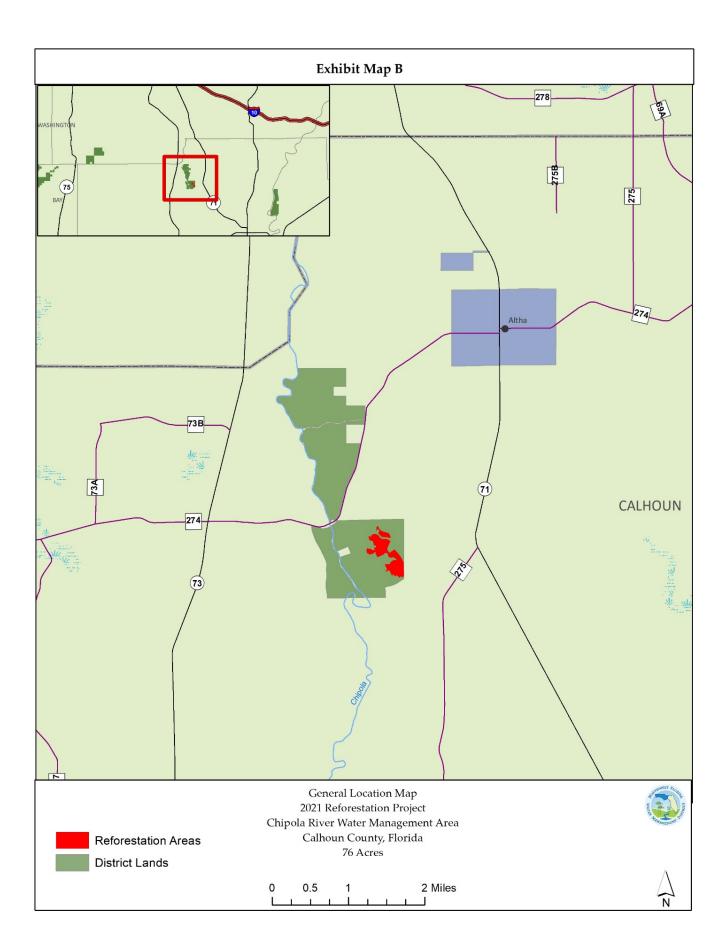

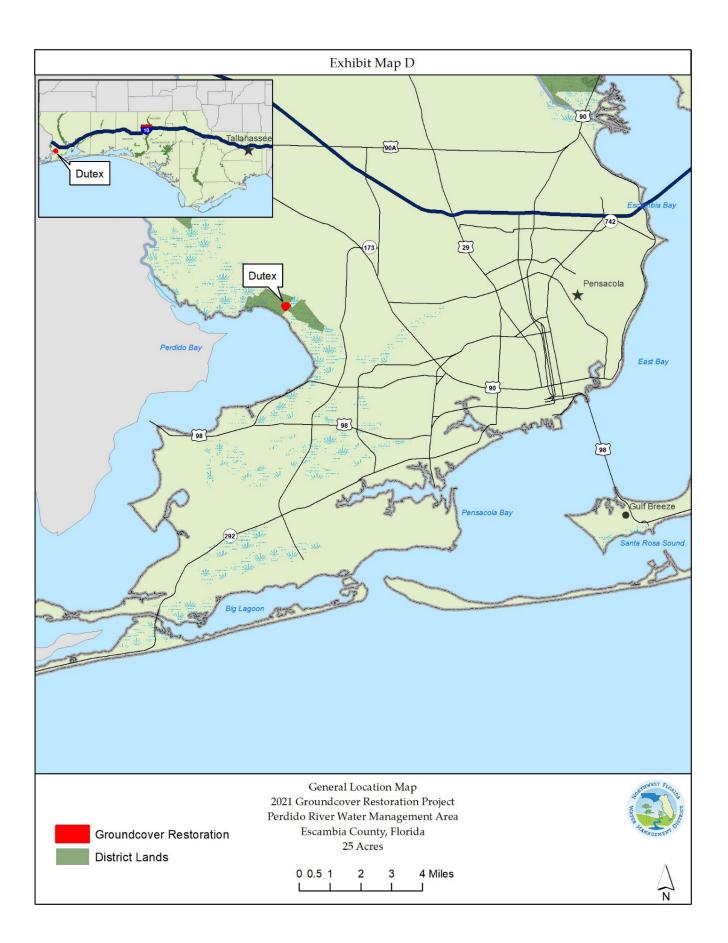

There are no pending cases in which the District is a party.

*Carmen Diaz vs. Northwest Florida Water Management District, and Palafox, LLC* State of Florida, Division of Administrative Hearings Case No. 19-5831

In DOAH's Recommended Order issued on May 18, 2020, the ALJ reserved ruling on Palafox's Motion for Attorney's Fees and Sanctions. A hearing was held on that Motion on August 19, 2020. The District did not participate in the Hearing.

On October 30, 2020, DOAH issued a Supplemental Recommended Order, wherein the ALJ recommended that the District enter a final order finding that Palafox is entitled to an award of its reasonable attorney's fees and costs incurred in defending the Amended Petition. The fees and costs would be owed by Ms. Diaz because she brought her Amended Petition for an improper purpose (only seeking to delay issuance of the District's permit and increase Palafox's costs to obtain it). The amount of the award would be determined by DOAH on remand by the District.

The parties are entitled to file exceptions and responses to the Supplemental Recommend Order with the District and to request a hearing before the Board prior to issuance of a Final Order. We will keep the Board apprised of these further proceedings.

On October 30, 2020, DOAH also issued a Final Order in a newly opened case brought by Palafox against Ms. Diaz's attorney, Jefferson Braswell, seeking attorney's fees and costs from Mr. Braswell based on his filing of pleadings for an improper purpose. In the Final Order, the ALJ found that Palafox is not entitled to fees and costs from Mr. Braswell. This Final Order does not require further action from the District.
