SUBJECT:	Request for Authorization to Proceed with Rule Development for Chapters 40A-1 and 40A-2, Florida Administrative Code

Program:

General and Procedural Rules, Chapter 40A-1, Florida Administrative Code (F.A.C.) Regulation of Consumptive Uses of Water, Chapter 40A-2, F.A.C.

Issue:

The Florida Department of Environmental Protection (Department) recently completed the rulemaking process for Chapter 62-40, F.A.C., in May 2014. As a result, Chapter 40A-2, F.A.C., needs to be reopened to incorporate this additional language.

Discussion:

The Department's Office of Water Policy directed efforts by the five water management districts to streamline consumptive use permitting and bring statewide consistency to the program. As a result, changes to Chapters 40A-1 and 40A-2, F.A.C., were implemented in May 2014; however, additional language in Chapter 62-40, F.A.C., made by the Department earlier in the year, needs to be incorporated. Correspondingly, references within Chapter 40A-1 and 40A-2, F.A.C., need corrections.

Recommendation:

Staff requests authorization to initiate rule development for Chapters 40A-1 and 40A-2, F.A.C., to incorporate additional language from Chapter 62-40, F.A.C., and correct references made during the statewide rulemaking effort.

Authorization Statement:

The District authorizes, as limited by the attached conditions, the use of 0.76 million gallons per day (mgd), annual average, (24.1 million gallons per month maximum; 277.4 million gallons per year) of groundwater from the Floridan aquifer for fire and boiler use; and 129.6 mgd, annual average, (4,119 million gallons per month maximum; 47,304 million gallons per year) of surface water from the Apalachicola River for cooling use.

RECOMMENDED PERMIT DURATION AND COMPLIANCE REPORTING:

Staff recommends that the applicant be granted an Individual Water Use Permit to authorize withdrawals of surface water and groundwater according to "Specific Condition No 1" below. Staff also recommends that the expiration date of the permit be July 1, 2024, and that the permit be conditioned in accordance with Exhibit A of the permit document.

DESCRIPTION:

The Gulf Power Company Scholz Generating Plant (GPC) located near Sneads in eastern Jackson County, was built in 1953 and services the northwest Florida area. The plant is capable of generating up to 98 megawatts of electricity and operates on pulverized coal. To provide cooling water to the plant, the applicant is authorized to withdraw an average daily surface water amount of 129.6 million gallons per day (mgd) from the Apalachicola River via four surface water withdrawal facilities. Approximately 96% of the surface water is returned to the Apalachicola River. GPC estimates that 276,000 gallons per day (gpd) of recycled surface water (condenser water) and an undetermined amount of storm water are used at the plant for ash sluicing. The applicant is also authorized to withdraw an average daily ground water amount of 760,000 gallons from two Floridan aquifer supply wells (one 12-inch and one 16-inch diameter well) for fire and boiler use.

Coal firing operations at the Scholz Plant will cease in the year 2015, but GPC has indicated the necessity of maintaining currently permitted withdrawal limits for the permit duration. This is due to GPC investigating the feasibility of utilizing alternative fuels at the plant.

Staff previously used the program DRAWDOWN to analyze the potential impacts to the Floridan aquifer associated with the average daily withdrawal of groundwater at the recommended average daily rate. The simulated drawdowns were 4.0 feet and 3.5 feet at one-half and one mile, respectively, from the center of pumping.

Staff also evaluated potential impacts to the Apalachicola River resulting from the average daily rate by analyzing average streamflow data recorded at the United States Geological Survey (USGS) gauging station for the Apalachicola River at Chattahoochee and minimum flows (7Q10) derived from USGS Water-Resources Investigation Report 93-4165. The total average daily withdrawal rate represents approximately 3.82% of minimum flow conditions. The average daily rate with 96% return represents approximately 0.15% of minimum flow conditions.

PERMIT APPLICATION REVIEW:

Section 373.223, Florida Statutes (F.S.), and Section 40A-2.301, Florida Administrative Code (F.A.C.), require an applicant to establish that the proposed use of water:

- (a) Is a reasonable-beneficial use;
- (b) Will not interfere with any presently existing legal use of water; and,
- (c) Is consistent with the public interest.

In addition, the above requirements are detailed further in the District's Water Use Permit Applicant's Handbook. District staff have reviewed the water use permit application pursuant to the above-described requirements and have determined that the application meets the conditions for issuance of this permit. Highlights of the staff review are provided below.

REASONABLE-BENEFICIAL CRITERIA

Economic and Efficient Use - Section 2.4 (a)

The recommended groundwater and surface water allocations are based on the currently permitted withdrawal amounts, and are the flow rates necessary for the plant to run at capacity. An analysis of the Permittee's pumping for the period of record (2005 – 2012) show that pumping is significantly below permitted amounts and has decreased over the permit duration. Although coal fired operations will cease in the year 2015, GPC will maintain the facility and plans to conduct pilot studies to determine the feasibility of utilizing alternative fuels at the plant.

Environmental Harm – Sections 2.4 (f), (g)

Staff used the program DRAWDOWN to analyze the potential impacts to the Floridan aquifer from the proposed pumping. The DRAWDOWN program is based on the Theis solution, an equation used to calculate changes in hydraulic head in a confined, homogeneous aquifer under transient conditions. The simulated drawdowns in the Floridan aquifer are considered to be minor and are not anticipated to cause harm to water resources or existing legal users.

Staff also evaluated potential impacts to the Apalachicola River resulting from the average daily rate by analyzing average streamflow data recorded at the United States Geological Survey (USGS) gauging station for the Apalachicola River at Chattahoochee and minimum flows (7Q10) derived from USGS Water-Resources Investigation Report 93-4165. Accounting for a 96% return rate, the requested withdrawals represent a minor use of the Apalachicola River under minimum flow conditions, and are not anticipated to cause harm to water resources or existing legal users.

RECOMMENDATION:

It is the determination of the staff that the water use amounts recommended, as conditioned, are reasonable-beneficial, consistent with the public's interest, and will not harm the water resources of the area or interfere with existing legal users. This determination has been made according to provisions of Chapter 373, Florida Statutes, and Chapter 40A-2, Florida Administrative Code.

Staff recommends that the applicant be granted an Individual Water Use Permit for an annual average daily withdrawal of 0.76 million gallons (277.4 million gallons per year) and a maximum monthly withdrawal of 24.1 million gallons of groundwater; an annual average daily withdrawal of 129.6 million gallons (47,304 million gallons per year) and a maximum monthly withdrawal of 4,119 million gallons of surface water. Staff also recommends that the expiration date of the permit be July 1, 2024, and that the permit be conditioned as per the "Conditions for Issuance" included in Exhibit A of the permit document.

- 2. The Permittee shall include the Individual Water Use Permit number and shall reference each well by its Florida Unique Well Identification Number (FLUWID) and each surface intake by its facility identification when submitting reports or otherwise corresponding with the District.
- 3. The Permittee shall maintain, in working order, an in-line, totalizing flow meter on each Floridan production well (AAA8617 and AAA8616) and Apalachicola River intake. The Permittee may use one meter for all Apalachicola River intakes if configured with a manifold. All meters shall be maintained to be at least 95% accurate and any meter determined defective must be replaced within 30 days of its discovery. The Permittee, by February 1, 2021 and at the time of requesting a permit modification or renewal, shall submit documentation of the flow meter calibration and accuracy rating to the District using Flow Meter Accuracy Water Use Report Form 170.
- 4. This Permit authorizes the Permittee to make a combined average annual withdrawal of 130.360 million gallons of water per day and a combined monthly withdrawal of 4,143.100 million gallons. Withdrawals for the individual facilities are authorized as shown in the table below in the following condition. However, the total combined amounts of water withdrawn by all facilities listed shall not exceed the amounts identified above.
- 5. The Permittee, by January 31 of each year, shall submit a water use report for the previous calendar year (January December) even if no water is used. The Permittee shall record the data required on Water Use/ Pumpage Report Form 172 and include a meter reading taken at the end of each month. The Permittee, if preferred, may submit the report electronically by downloading the correct form from the District website, filling it out properly, and e-mailing it to <u>compliance@nwfwmd.state.fl.us</u>. The next report is due by January 31, 2015.
- 6. The Permittee shall continue to return at least 96% of the surface water withdrawn from the Apalachicola River.
- 7. The Permittee shall encourage and provide for the efficient and non-wasteful use of water, and shall implement water conservation measures, including a proactive leak detection program, designed to enhance water use efficiency and reduce water demand and water losses.
- 8. The Permittee shall submit a compliance report by July 1, 2019. At a minimum, the compliance report must include sufficient information to demonstrate continued reasonable assurance that the Permittee's use of water will continue to meet the conditions for permit issuance set forth in Rule 40A-2 for the remaining duration of the permit. The compliance report shall also include:

No Quantity or Quality Changes: Documentation that continued use of withdrawal quantities authorized under this permit will not cause quantity or quality changes that adversely impact the water resources, including both surface and ground waters.

Conservation: Documentation that use of the permitted withdrawal quantities is efficient and that the Permittee is implementing reasonable and feasible water conservation measures to reduce withdrawals from the Floridan aquifer so that the groundwater quantities used for its augmentation can be reduced or eliminated.

No Impacts to Existing Legal Withdrawals: Documentation that the continued use of the withdrawal quantities authorized under this permit will not adversely impact existing legal withdrawals.

No Impacts to Water Resources: Documentation that the continued use of the withdrawal quantities authorized under this permit will not adversely impact springs and surface waters, or water bodies for which minimum flows and levels have been established by the District.

9. The Permittee shall mitigate impacts that interfere with existing legal users of Floridan aquifer groundwater. Mitigation may include modification of the Permittee's pumping schedule (i.e., duration, withdrawal rates, time of day, etc.), the lowering of the affected pump(s) or the replacement of the well(s) including proper plugging and abandonment of the well(s) that is replaced. The Permittee, upon receipt of an allegation of interference, shall retain the services of an appropriate licensed professional to investigate the alleged interference. The Permittee shall ensure their chosen professional investigates any alleged interference within 48 hours of the allegation being made and provides the conclusions of the investigation to the entity alleging the impact within 72 hours of the allegation being made. If it is determined that the use of a well has been impaired as a result of the Permittee's operation, the Permittee shall undertake the required mitigation. The Permittee, within 30 days of any allegation of interference, shall submit a report to the District including the date of the allegation, the name and contact information of the party making the allegation, the result of the investigation made and any mitigation action undertaken.

- 2. The Permittee shall maintain, in working order, in-line totaling flow meters at each well. The Permittee shall install, by September 1, 2011, and thereafter maintain, in working order, in-line totaling flow meters at each surface water intake (LS #1, LS #2, and GC #1).
- 3. The Permittee shall limit total surface water withdrawals (via intakes LS #1, LS #2, and GC #1) to an average daily amount of 54,000 gallons, a maximum daily amount of 134,600 gallons, and a maximum monthly amount of 3,390,000 gallons.
- 4. The Permittee, prior to withdrawing ground water from wells EBR #4 and EBR #5, shall maximize the use of surface water in the stormwater ponds.
- 5. The Permittee shall utilize the Floridan Aquifer wells (wells EBR #1 and EBR #2) only for emergency back-up use to supplement the stormwater ponds during times when both wells EBR #4 and EBR #5 are inoperable.
- 6. The Permittee, by January 31, April 30, July 31, and October 31 of each year, shall report the data required on Water Use Summary Reporting Form NWFWMD A2-I for the preceding three months. The ground water and surface water withdrawals shall be reported separately by withdrawal facility and source. The Permittee shall report the total amounts withdrawn from each source. The Permittee, if preferred, may submit the report electronically by downloading the correct form from the District website, filling it out properly, and e-mailing it to compliance@nwfwmd.state.fl.us.
- 7. The Permittee shall operate the irrigation systems in an efficient and non-wasteful manner. The Permittee shall limit irrigation activity to the lower evapotranspiration period from 4:00 p.m. to 10:00 a.m. The Permittee shall frequently evaluate the efficiency of each of its irrigation units and undertake necessary maintenance, repairs, and upgrades to provide for the proper efficiency of its equipment. Runoff from the irrigation system shall be minimized by adjusting sprinkler direction and the timely repair of any leaks. The Permittee shall utilize rain sensing or similar devices which override the automatic irrigation systems with an anti-siphoning device if chemicals are to be applied through the irrigation system.
- 8. The Permittee, to the extent feasible, shall implement for the golf courses all practices identified in the document Best Management Practices for the Enhancement of Environmental Quality on Florida Golf Courses (2007). The document can be accessed at the website: http://www.dep.state.fl.us/water/nonpoint/docs/nonpoint/glfbmp07.pdf. The Permittee, by January 31 of each year, shall report all practices implemented during the previous year by utilizing Appendix E, the Golf Course Best Management Practices Checklist.

Recommendations:

Staff is asking the Governing Board to: (1) make a determination that the 1,176.6 acres are not required for District purposes but instead are best used for consolidation and management with other agency-owned lands by the Department of Environmental Protection; and (2) in furtherance thereof, donate this acreage to the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida pursuant to Chapter 373.056, Florida Statutes. In addition, staff recommends that the Governing Board choose not to reserve the interest in the property's phosphate, minerals, metals and petroleum, if any.

Background:

During the last several months, District staff has been holding discussions with staff of the Florida Department of Environmental Protection (DEP) and the Florida Fish and Wildlife Conservation Commission (FWC) regarding the possible donation of 1,176.6 acres of District property along East Bay in Santa Rosa County, otherwise known as the Grassy Point tract, to the Board of Trustees of the Internal Improvement Trust Fund. This discussion began due to a request by FWC for access through the District's Grassy Point tract to their recently acquired Escribano Point tract on our western boundary along East Bay.

In 2001, the District acquired 1,176.6 acres from Amerivest Mortgage Emerald Point Development for \$3,625,000 or \$3,080.91 per acre. Funding sources used to acquire this

tract included Florida Forever (purchased 204.5 acres) and Save Our Rivers (purchased 972 acres).

This tract is located in southeastern Santa Rosa County and is bisected by Choctaw Field Road. This tract adjoins the boundary of FWC managed lands at Escribano Point on its northern, southern and western boundaries, as well as adjoins Eglin Air Force Base on its eastern boundary. The tract has frontage on East Bay, Catfish Basin and Fundy Bayou and is not contiguous to other lands owned by the District in the Yellow River WMA.

FWC's goals for managing the Grassy Point tract will generally be to conserve, protect, and restore natural resources while providing quality resource-based recreational opportunities for Floridians and other visitors. The District's two primitive campgrounds and boat launch along Fundy Bayou will be maintained and regulated to minimize adverse impacts from public uses. FWC will continue all land management practices put in place by the District, including preserving and enhancing water quality, maintaining and restoring natural communities, promoting a diversity of wildlife habitats, and providing low-impact, high quality natural resource-based recreational opportunities. In addition, FWC will work to preserve and maintain the condition of any cultural or archeological resources. The goals for managing the Grassy Point tract will be implemented in conjunction with parcels already managed by FWC in the area in order to restore and/or enhance hydrological and ecosystem function to the area.


DEP and FWC staff have conducted preliminary reviews of the District's boundary map/acreage certification, title work and Phase I Environmental Site Assessment and have found no major concerns related to this proposed donation. FWC has determined that there does not appear to be any major impediments to FWC's management of the Grassy Point tract and that it will substantially enhance their operational, resource protection and recreational management capability at Escribano Point. As such, FWC is willing to accept management authority and responsibility for the Grassy Point tract and DEP has agreed to accept the title to the property.


District staff concurs with FWC's findings, proposed management activities and recommends that staff move forward to donate this tract to the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida. By donating this tract to DEP, staff estimates that the District may reduce the Yellow River WMA's overall land management cost by an average of \$71,876 annually.

Pursuant to 373.056(4), F.S., the District has the authority to convey to any governmental entity land or rights in land owned by the District not required for its purposes, under such terms and conditions as the Governing Board of the District may determine.

SUBJECT:	Consideration of Consulting Services for Minimum Flows and Levels Development for the St. Marks River Rise, Wakulla Springs and Sally Ward Spring

Recommendation:

Staff recommends the Governing Board authorize the Executive Director to spend up to \$375,000 to support the development of minimum flows and levels for the St. Marks River Rise, Wakulla Springs, and Sally Ward Spring.

Discussion:

Section 373.042(1), Florida Statutes, requires each water management district develop minimum flows and levels (MFLs) for specific surface and groundwater bodies within their jurisdiction. The minimum flow or level for a given waterbody is the limit at which further withdrawals will be significantly harmful to the water resources or ecology of the area.

The multi-year process required to establish an MFL involves a series of steps including data collection, technical assessments, rule-making and adoption of District rules. The technical assessment for the first MFL, the St. Marks River Rise—a first magnitude spring in southeastern Leon County—will be completed in 2018, and for Wakulla Springs and Sally Ward Spring in 2021. A combined work plan for the development of the technical assessments for these three water bodies was completed in June.

Activities during the next three months will focus on data collection and work to support the development of a groundwater flow model. Data collection activities will include well construction and testing, installation of surface water stations, and monitoring of ground and surface water levels, flows, and water quality. The scopes of work for this effort will be detailed in several task orders to be issued under the existing contractual services agreements with MFL consultant teams and through purchase orders and Joint Funding Agreements with the U.S. Geological Survey.

In order to facilitate the timely progression of MFL development, staff recommends the Executive Director be authorized to expend up to \$375,000 approved in the FY 2013-2014 budget for activities described above.

Northwest Florida Water Management District v. Jan Sebastian, State of Florida, Division of Administrative Hearings, Case No. 14-2793. This case involves the issuance by the District of a Notice of Violation and Order for Corrective Action, File No. MSSW 04-2011-001 14 1948, to Sebastian in order to enforce Chapter 373, Part IV, Florida Statutes, and Chapter 62-330, Florida Administrative Code, for the failure by Sebastian to properly maintain the dam on her property and ordering Sebastian to comply with District rules and repair the emergency spillway of the dam to the standards set forth in Rule 62-330, Section 2.11 of the Applicant's Handbook Volume II. In response to the Notice of Violation and Order for Corrective Action, Sebastian petitioned for administrative hearing alleging primarily that she is not the party responsible for the repair of the dam.

This is an enforcement action taken against a property owner for improper modification of and failure to maintain a dam. The final hearing before Administrative Law Judge Bram D. E. Canter has been set for August 26 - 27, 2014, in Tallahassee.
