SUBJECT: Consideration of Resolution No. 809 Amending the Fiscal Year

2015-2016 Budget - Amendment No. 1 - Realignment of Budget

#### **Recommendation**

Staff recommends the Governing Board adopt Resolution No. 809 amending the Fiscal Year 2015-2016 Budget and allow staff to realign revenues and reserves to maintain the proper balance in each fund.

# **Background**

Amendment No. 1 to the Fiscal Year (FY) 2015-2016 Budget realigns budget within and across programs, funds, projects, and categories. This amendment does not increase or decrease the total District budget.

A review of year-to-date and projected expenditures indicates this action is required to properly reflect budgetary needs with associated costs for the remainder of this fiscal year. Budget realignments include:

- \$312,684 in personnel budget transfers across programs and projects to accurately reflect where staff time is being charged:
  - \$144,883 for Division of Resource Management to redistribute budget from a single FEMA project and a single National Fish and Wildlife Foundation project to multiple FEMA and NFWF projects for better expense tracking, as well as reallocate budget to reflect priority changes in operations.

- \$167,801 for Division of Regulatory Services to align Other Personal Services budget with the Division's reorganization that occurred in FY 2014-15.
- \$61,225 in contractual service and operating expense transfers within the Division of Land Management to provide:
  - \$26,250 in consulting services for the development and implementation of Phase II of the land management database.
  - o 34,975 in preacquisition services (e.g., appraisal, review appraisal, title insurance) to acquire land for spring protection.
- \$35,708 in contractual service and operating expense transfers within the Information Technology (IT) Bureau to correctly recognize costs of the Online Recreation Reservation System in one project rather than across multiple IT projects.
- \$219,275 in contractual service transfers within the Division of Resource Management to provide:
  - o \$1,200 for legal counsel services related to the ACF litigation.
  - \$200,000 in management consultant transfers to be allocated among three separate FEMA projects to reflect awarded grant directives.
  - o \$2,500 in legal counsel services realigned to cover expenses where needed.
  - \$15,575 for data collection to provide funding for the surface water monitoring of St. Marks River Swallet.
- \$44,690 in management consultant and operating expense transfers to budget across four separate tasks to comply with National Fish and Wildlife Foundation funding requirements for the District's SWIM plan update project.
- \$7,950 in operating expense transfers within the Division of Resource Management to provide:
  - \$1,225 for the purchase of public outreach signs for stormwater outfalls in Franklin County.
  - o \$4,725 for procurement of tubelings and seedlings to support emergent restoration requirements from a Florida Department of Transportation credit release at Yellow River Ranch.
  - \$2,000 for staff travel needs related to Region II well construction for the MFL program.
- \$2,871 in operating expense transfers for replacement of office furniture and equipment across the District.
- \$1,500 for the purchase of a gate at Dutex Mitigation Bank via a transfer from contractual services to operating capital outlay within the Division of Resource Management budget.

- \$1,000 in operating expense transfers across projects with the Regulatory Services budget.
- \$500 in operating expense transfers across programs to accurately reflect where on-line data services are being charged.
- \$35 for District-provided clothing/uniform expenses, redistributing a portion of the original lump sum budget from the Division of Administration to the Division of Resource Management.

Amendment No. 1 reallocates budget authority across programs, funds, projects, and budget categories to properly reflect activities performed and accurately assign actual costs with no increase to the total District budget.

# **Recommendation**

Staff recommends the Governing Board authorize the removal of missing items from the property records, once the six-month waiting period has expired.

#### **Background**

After staff conducts an annual physical inventory of all recorded fixed assets, if an item cannot be located, it is initially listed as "lost or stolen." Once an item is placed in a lost or stolen status, a diligent search begins that continues for at least six months. Items that are recovered are placed back in active status. Items that cannot be located are eventually brought to the Governing Board for permission to write off the loss and adjust the property records and assets account.

Depreciation requirements mandated by federal financial reporting make it necessary to delete the lost items and adjust the asset records after the six-month search to avoid overstating depreciation expense and the value of District assets.

During the Fiscal Year 2014-2015 physical inventory the items below were not able to be located, but remain on the District's property records. Memos are attached that explain what did or may have happened to these items. The most common reason provided is that due to their age, they were likely determined to have no further value to the District and were previously disposed of.

Tag # 2788: In July 2013 this data logger was installed at Station 749, Pine Log Creek @ Baptismal Hole in Bay County. It was submerged by floodwater and the electronics in the unit were damaged and assessed as not repairable. It was added to a large collection of surplus equipment, staff did not properly document disposal of this data logger. Proper documentation will be completed for all future equipment when it is surplused.

Tag # 3175: This OTT PLS sensor failed when deployed in the field and was surplused with other inoperable/non-repairable field equipment. The OTT PLT sensors typically have an operational life of 2-4 years, these units are installed under water and can be damaged by lightning and environmental conditions. Repair costs for these sensors are equivalent to new sensor cost when these sensors fail outside of the warranty period, the warranty period is one years. Because this sensor was a submersible deployed instrument it did not have a physical property tag on it. When it was retrieved from the field it was added to a large collection of inoperable surplus equipment and staff did not properly document disposal of this sensor. Proper documentation will be completed for all future field equipment when it is surplused.

Tag # 3189: This OTT PLS sensor was deployed at Station 22, St. Augustine Branch @ Orange Ave in Tallahassee. In October 2014, the City of Tallahassee began construction to repair culverts at this location without properly notifying the District. A backhoe struck the sensor housing destroyed the sensor beyond recovery. This was not properly documented by District staff at the time. Proper documentation will be completed for all future incidents when equipment is damaged or destroyed.

SUBJECT: Consideration of Suitability of Selected District Lands for Cattle Grazing

#### Recommendation

Staff recommends the Governing Board authorize staff to offer for lease the properties known as the Grisset Pond Tract and the Wolf Pond Tract for cattle grazing. If approved, staff will develop a draft Invitation to Bid and lease agreement for consideration at a future Lands Committee and Governing Board meeting. Any and all costs of improvements to make the sites viable for cattle grazing, e.g., fencing, would be the responsibility of the lessee.

#### **Discussion**

In July 2015, Roger West (Professor Emeritus, Dept. of Animal Sciences, University of Florida) evaluated the suitability of properties owned by the District for cattle grazing. Dr. West assessed nine specific sites in detail based on forage availability and grazing management needs, such as fencing, water availability, handling facilities and ease of access. He graded the sites as "high," "medium" and "low" for grazing suitability. An overview of Dr. West's assessment was provided at the December 2015 Governing Board meeting.

A "high" score by Dr. West indicated the parcel can support 50 or more cow/calf units; the minimum number he considers necessary to make a cattle operation potentially viable. This score is further based on the determination by Dr. West of the number of acres required per cow annually. A "medium" or "low" rating indicates inadequate available forage, high fencing costs or inadequate tract size for economic viability. Dr. West's evaluation did not include any analysis of potential impacts to water resources from cattle grazing on the particular sites.

District staff subsequently evaluated the four sites Dr. West assessed as having a "high" suitability for cattle grazing for potential water resource impacts. Water resource values included in the District's review included habitat, land cover, affected waterbodies, and potential for nutrient loading to water resources from cattle grazing.

The four sites evaluated are the Grisset Pond, Wolf Pond, Garcon Point, and Hobbs Pasture tracts. Of the four sites, the Grisset and Wolf Pond tracts were assessed as being both suitable for grazing and as having minimal potential for significant impacts to water resources (at stocking rates of one cow/calf unit per 20 acres). Nitrogen loading into receiving waters from these sites is expected to be insignificant as long as appropriate Department of Agriculture and Consumer Services Best Management Practices (BMPs) are applied; there is no supplemental feeding; and no additional nutrient amendments or fertilizer are applied to the property.

A description of each of the four sites scored as "high" by Dr. West, along with the resource characteristics and considerations evaluated by staff, are provided below and summarized in Table 1.

#### **Site Descriptions**

Grisset Pond Tract is a 1,145-acre tract consisting primarily of upland forest, along with wetlands adjacent to Econfina Creek and Grisset Pond. A little over six percent of the property consists of wetlands. Cattle grazing within the 260 acres of forested sandhill uplands and longleaf pine stands on the property, at appropriate stocking levels and with the implementation of BMPs, is not expected to harm the water resources. Best management practices for this particular site would include installation of approximately 24,451 linear feet (4.6 miles) of new fencing and limiting grazing intensity. The fencing is necessary to exclude cattle from wetlands, pond areas, and recently established longleaf pine restoration areas. Use of the property for cattle grazing would require a local comprehensive plan amendment.

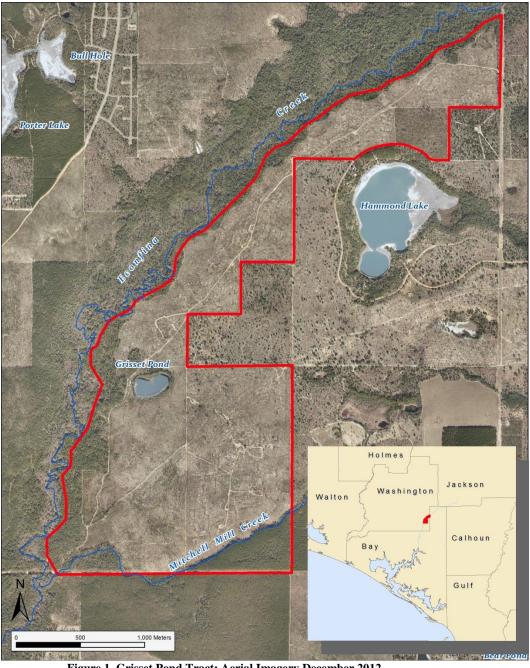


Figure 1. Grisset Pond Tract; Aerial Imagery December 2012

Wolf Pond Tract is a 2,223-acre site characterized by sandhill uplands, numerous steep-sided depressions, and sandhill ponds, including Wolf Pond. Cattle grazing within 796 acres of sandhill uplands, at appropriate stocking levels and with appropriate BMPs, is not expected to harm water resources. Up to 1,116 acres of young longleaf pine restoration stands and recent sand pine harvesting areas should be excluded to protect newly planted pine trees from damage from grazing activity and to ensure the success of habitat restoration efforts. Approximately 50,575 linear feet (9.6 miles) of new fencing will be required on this tract to follow the BMP guidelines.

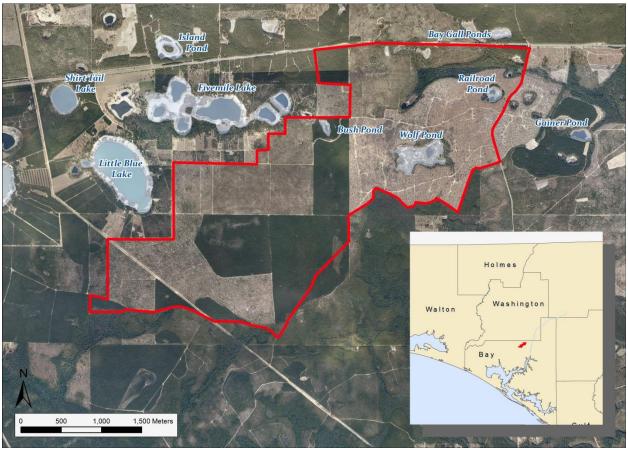


Figure 2. Wolf Pond Tract; 2012-2013 Aerial Image and Vicinity

Garcon Point Tract is a 980-acre property that consists entirely of wetlands. Based on a site inspection and a detailed review of available data, staff concluded cattle grazing onsite has the potential to adversely affect sensitive wetland resources and water quality within adjacent waterbodies. Adverse effects could include erosion and compression of wetland soils and changes to the vegetation communities. Of notable importance to the protection of surface water quality are the forested wetlands along the primary drainages to Blackwater and Escambia bays. The site was acquired to protect sensitive wetlands and water resources on and adjacent to the property. The site is also within the area designated by Santa Rosa County as the Garcon Point Protection Area, which was established to protect sensitive lands. Agricultural uses onsite would require both a comprehensive plan amendment and zoning variance or reclassification.

As the Garcon Point Tract is composed of almost 100 percent wetlands, it is staff's recommendation that the site be excluded from consideration for cattle grazing.

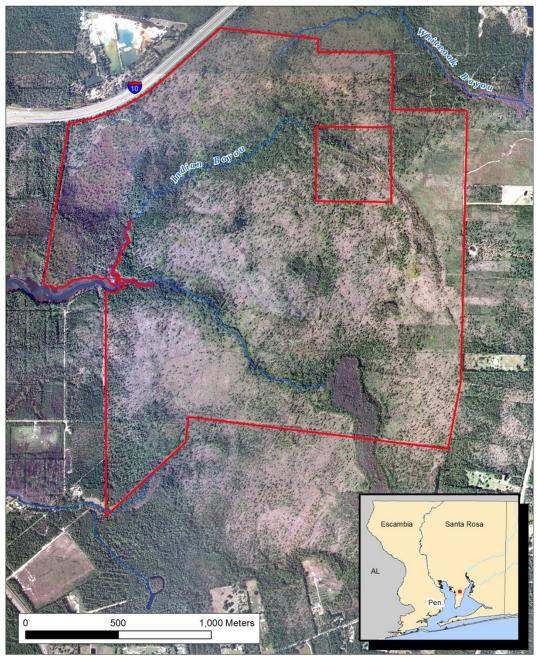


Figure 3. Location Map: Northern Tract of the Garcon Point Water Management Area

**Hobbs Pasture Tracts** cover 1,693 acres split between two tracts, 670 acres in the north and 1.024 acres in the south, which are adjacent to Econfina Creek and Deer Point Lake Reservoir. The reservoir is a Class 1 waterbody that serves as the primary source of potable water for Bay County. A county water supply pump station is located on the property near the convergence of Econfina Creek and the reservoir. Protection of wetlands and streams intersecting the property that drain to the reservoir, as well as newly restored longleaf pine habitat areas and boundary fencing, would require more than 103,629 linear feet (19.5 miles) of new fencing to protect resources.

Approximately 32 percent of the Hobbs Pasture property is wetlands. Based on a site inspection and a data review, staff concluded wetland resources and functions and surface waters at Hobbs Pasture have the potential to be adversely affected by onsite cattle grazing. Such impacts could include erosion and sedimentation, compression of wetland soils, changes to vegetation communities, and, if grazing is conducted proximate to wetlands and surface waters, the potential to increase bacteria and nutrient

concentrations. Riparian wetlands along the streams draining the property help protect surface water quality and support fish and wildlife habitat. The interior herbaceous wetlands also provide important functions, including floodwater storage and natural management of discharge, nutrient cycling, aquifer recharge, and wildlife habitat.

Considering the proximity of the public water supply pump station and reservoir, as well as the extent of fencing required to protect water resources, it is staff's recommendation that the Hobbs Pasture tracts be excluded from consideration for cattle grazing.

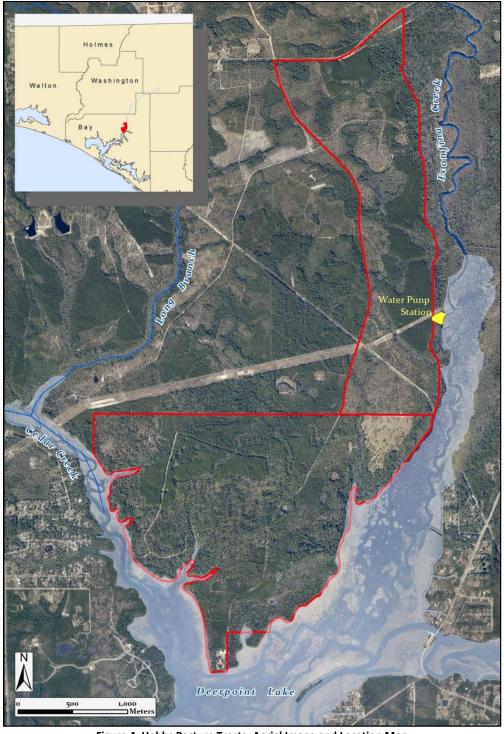


Figure 4. Hobbs Pasture Tracts. Aerial Image and Location Map

Progress Update

#### **Background**

Sections 373.451-459, Florida Statutes, the "Surface Water Improvement and Management (SWIM) Act," established the Legislature's intent that water management districts develop plans and programs for improvement and management of surface waters. More specifically, the Act requires districts, in cooperation with the Florida Department of Environmental Protection and other state agencies and local governments, to prioritize waterbodies of regional significance, and it authorizes districts to develop SWIM plans and programs for priority waterbodies.

From the 1980s through the early 2000s, the District developed SWIM plans to guide and support watershed management and restoration across northwest Florida. These plans are an important resource for the District and for local governments and state agencies. They describe current conditions, priority issues, and recommended strategies and projects. The plans serve as a foundation for many of the District's priority projects, including stormwater treatment, wetland and aquatic habitat restoration, spring restoration, and analytical work to evaluate resource conditions. A defining characteristic of the SWIM program is that implementation is conducted primarily through cooperative projects, prioritized with regional stakeholders.

As discussed at the August Governing Board meeting, the District was awarded a \$695,000 grant from the National Fish and Wildlife Foundation (NFWF), through the Gulf Environmental Benefit Fund, to develop updated and current Surface Water Improvement and Management (SWIM) plans for each of northwest Florida's major riverine-estuarine watersheds. This work is part of a larger effort funded by NFWF, implemented in cooperation with the Florida Fish and Wildlife Conservation Commission, the Florida Department of Environmental Protection, and the Suwannee River Water Management District, to develop updated SWIM plans in both of the districts, to develop effective strategies for seagrass recovery, and to develop a comprehensive restoration strategy for the Florida Panhandle and Big Bend regions.

#### **Current Status and Plan Ahead**

In December, the District engaged consultant services to develop updated characterizations of watershed conditions and restoration priorities for six of our seven major watersheds:

- 1) Perdido Rivera and Bay;
- 2) Pensacola Bay System;
- 3) Choctawhatchee River and Bay;
- 4) St. Andrew Bay;
- 5) Ochlockonee River and Bay; and
- 6) St. Marks River and Apalachee Bay.

These characterizations are expected to provide major components of the final plans. Building upon this effort, the District will work with local governments, state agencies, and other stakeholders to identify and further define appropriate strategies and current project priorities to most appropriately address the challenges facing each watershed. For the seventh watershed, the Apalachicola River and Bay system, staff will work directly with local governments, resource agencies, and other stakeholders to develop an updated watershed assessment and project plan.

Beginning this spring, the District plans to conduct technical advisory meetings for each of its watersheds. These meetings will be held with representatives of local governments, state and federal resource agencies, and regional watershed initiatives. Separate meetings will be held within or near each of the District's watersheds. Public outreach activities, to include workshops, will follow during fiscal year 2016-2017. All information presented at the technical meetings and public workshops, as well as draft and final SWIM plans and supporting documentation, will be made available to the public through the District's website. Input and recommendations received from the public and from governmental and other technical stakeholders will be important for establishing the final direction and specific content of the proposed plans, which will be brought forward for the Governing Board's consideration at the conclusion of the process, late in 2017.

Management District

#### **Recommendation:**

Staff recommends the Governing Board approve the renewal of the 20-year Maintenance Agreement between the Board of County Commissioners of Santa Rosa County and the Northwest Florida Water Mangement District.

#### **Background:**

A considerable cost savings to the public has been achieved through a 20-year Maintenance Agreement with the Board of County Commissioners of Santa Rosa County (Santa Rosa County). In 1996, the District entered into two 20-year Maintenance Agreements with Santa Rosa County for five recreation sites. These recreation sites included three local boat launches along the Escambia River at Quintette, Webb and Keyser Landings, as well as a boat launch and camping area at William's Lake on the northern Escambia River. The Distirct and Santa Rosa County also developed the Simpson River Recreation Area, which includes a kayak launch and fishing pier located at Hwy. 90 where it crosses northern Escambia Bay (see attached recreation site location map).

Through the current agreements, Santa Rosa County has provided labor and equipment for the installation, maintenance and repair of improvements at these sites and associated parking areas. This includes, but is not limited to, structural modifications for stormwater management; construction, maintenance, and repair of boat ramps, and access routes to the property; maintenance of parking areas adjacent to recreation areas; general grounds maintenance including litter pick up and removal; and law enforcement services.

The District has similar agreements with four other county commissions, i.e. Holmes, Jackson, Liberty, Walton and Washington counties as well.

Through these Maintenance Agreements, the District has had the ability to work with Santa Rosa County over the last 20 years to provide for the continued maintenance and management of these popular recreation areas and facilities at a substantial cost savings. Through the new agreement, District staff is consolidating the landings and recreational areas in the two agreements discussed above into one agreement and also adding the Keyser Landing recreation site. The proposed agreement will also cover any other recreational sites subsequently acquired or identified by the District and mutually agreed to by the County and the District. Upon approval of the new agreement, the 1996 agreements will terminate. If approved by the Governing Board and Santa Rosa County, the new agreement will be effective on March 25, 2016.

#### MAINTENANCE AGREEMENT

This AGREEMENT is between the NORTHWEST FLORIDA WATER MANAGEMENT DISTRICT, 81 Water Management Drive, Havana, Florida 32333-4712, hereinafter called "DISTRICT" and the BOARD OF COUNTY COMMISSIONERS OF SANTA ROSA, 6495 Caroline St., Suite M, Milton, Florida 32570, hereinafter called "COUNTY".

# WITNESSETH:

WHEREAS, the DISTRICT is the owner in fee simple of certain lands located in Santa Rosa County, Florida, hereinafter called the "Property", said Property being more particularly described on Exhibit "A" attached hereto and by this reference made a part hereof;

WHEREAS, the DISTRICT is responsible for preserving and protecting the water resources of the Simpson and Escambia Rivers by preventing erosion and deterioration of water quality and for providing maintenance and management of recreational sites on the Property;

WHEREAS, the COUNTY desires to assist the DISTRICT in enhancing general public recreational opportunities along the Simpson and Escambia Rivers by undertaking

management, maintenance and erosion prevention responsibilities for boat ramps and recreation facilities on the Property as the parties may from time to time agree upon;

WHEREAS, on April 11, 1996 and July 29, 1996, the DISTRICT entered into Maintenance Agreements (the "1996 Agreements") under which the COUNTY agreed to provide labor and materials necessary to perform certain maintenance and modifications to boat ramps and recreation facilities, including erosion prevention responsibilities, on the Properties;

WHEREAS, the DISTRICT and COUNTY both now desire to terminate the 1996 Agreements, and hereby waive the 60 day written notice for termination as outlined in paragraphs 11 and 13 thereof; and

WHEREAS, the DISTRICT and the COUNTY now desire to enter into this Agreement superseding and replacing in the entirety the 1996 Agreements.

NOW THEREFORE, for and in consideration of the premises which are made a part of this Agreement and the mutual covenants, terms and conditions contained herein, the DISTRICT and the COUNTY agree as follows:

- 1. The DISTRICT agrees to make available to the COUNTY the Property shown in Exhibit "A", as well as means of ingress and egress across DISTRICT property, for use by the general public for general recreational purposes.
- 2. The COUNTY agrees to maintain boat ramps, parking areas and other recreational facilities, as appropriate, at each of the recreational sites as described in Exhibit "A".

- 3. The DISTRICT agrees to prepare for the COUNTY detailed site plans for each recreational site as described in Exhibit "A" that, at a minimum, addresses stormwater management and erosion abatement, along with possible expansion of parking facilities.
- 4. The COUNTY agrees to provide labor and equipment for the installation, maintenance and repair of the improvements to be located on the Property, including boat ramps, parking areas, and other recreational facilities that might be agreed to by both parties. Such responsibility shall include, but not be limited to, structural modifications for stormwater management as directed by the DISTRICT in its discretion; construction, maintenance and repair of boat ramps and access routes to the Property; maintenance of parking areas adjacent to recreation areas; general ground maintenance including litter pick up and removal; and the provision for such law enforcement services as are usual and customary in order to allow the safe and orderly public utilization of the Property.
- 5. The DISTRICT and COUNTY agree to separately and/or jointly seek supplementary funding from available sources for said stormwater management, erosion prevention, maintenance and repair on the property.
- 6. Subject to mutual written agreement and to the availability of necessary funds, the COUNTY and DISTRICT shall provide other ancillary facilities such as, but not limited to, picnic and recreational facilities, as may be deemed necessary or desirable by the COUNTY and DISTRICT. Upon completion of such other ancillary facilities, if any, COUNTY agrees to assume maintenance responsibility for same.
- 7. The COUNTY shall keep the Property and facilities maintained in accordance with all applicable Federal, State and local health and safety standards and

kept in good repair to prevent undue deterioration, provide for safe public use and prevent water quality degradation of the Simpson and Escambia Rivers.

- 8. The DISTRICT and COUNTY covenant that they have full legal authority to enter into this Agreement and to develop, operate and maintain the Property, facilities and improvements in accordance with the terms of this Agreement.
- 9. The COUNTY expressly understands and agrees that the Property and surrounding land, in addition to being a component of the Property, is also managed and operated as part of a Wildlife Management Area by the Florida Fish and Wildlife Conservation Commission, and all regulations and rules for management and operation of the Property and facilities shall be in conformance with the rules and regulations, as may from time to time be amended, for operation and management of the Wildlife Management Area.
- 10. The DISTRICT reserves the right to prohibit or restrict access hours to facilities on the Property during periods of potential drought, flooding, fire hazard or other potential harm or disaster to said Property.
- 11. The DISTRICT and COUNTY shall each furnish a contact person who shall be responsible for coordination and resolution of problems arising from this Maintenance Agreement.

These contact persons or their representatives shall periodically jointly inspect the Property and, by mutual agreement, create work plans outlining needed development, maintenance and repair and improvement activities.

- 12. This Agreement is effective on March 25, 2016 and shall remain in effect for a period of twenty (20) years from the date hereof, though it may be extended by written agreement between the parties.
- 13. This Agreement may be terminated by the COUNTY or the DISTRICT upon thirty (30) days written notice to the other. In the event of such termination, the obligations of the parties hereunder shall cease, and the Property and all improvements located on the Property shall revert to the exclusive control of the DISTRICT.
- 14. This Agreement contains the complete agreement between the DISTRICT and the COUNTY and, as of the effective date hereof, shall supersede all previous communications, representations or agreements, either oral or written, between the parties hereto. The parties may mutually agree at any time by written instrument to amend this Agreement or renew this Agreement.
- 15. The Commission understands and shall comply with Section 20.055(5), Florida Statutes, which states: "It is the duty of every state officer, employee, agency, special district, board, commission, contractor, and subcontractor to cooperate with the

inspector general in any investigation, audit, inspection, review, or hearing pursuant to this section."

IN WITNESS WHEREOF, the parties hereto have executed this Agreement through their duly authorized officers and agents.

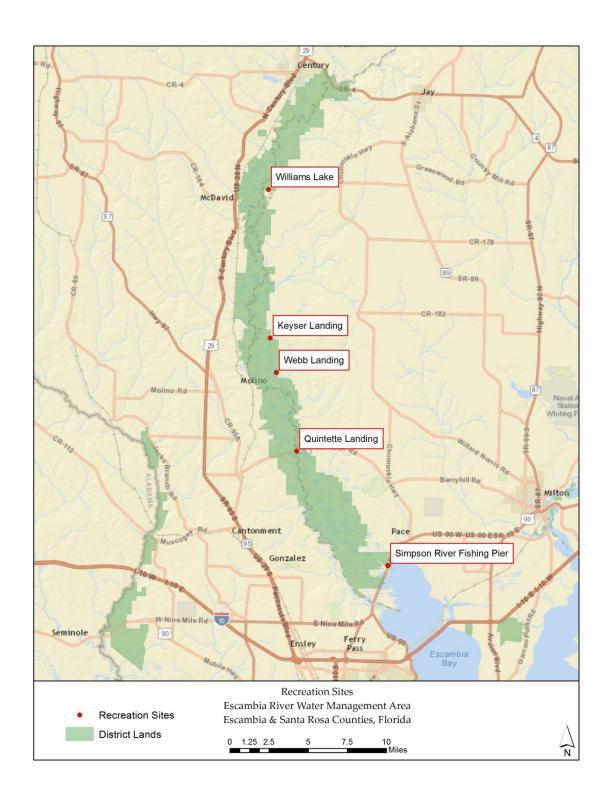

for Recreation Areas

# Recommendation

Staff recommends the Governing Board authorize staff to solicit and accept financial donations to support the management of District recreation areas.

#### **Background:**

In early 2015, the Governing Board directed staff to explore the possibility of accepting financial donations to support the management of its recreation areas. Subsection 373.083(4), Florida Statutes, allows for the public to make such donations. Revisions to the District's camping reservation system can be implemented that will allow the public to make donations should the Governing Board wish to do so.

# **Discussion**

The District owns more than 211,000 acres of conservation land and manages a number of popular public recreation areas located on these tracts. In the past few years, the District has increased the number of existing sites that can be reserved by users for camping, picnics, family reunions, etc., and has automated the process to allow free reservations to be secured through a website and mobile applications. There are currently 88 sites available for reservation within 28 recreation areas. In addition to these reservation sites, there are many first-come, first-served day-use areas, and thousands of acres where backcountry camping is allowed without a reservation.

The District undertakes the regular maintenance and cleaning of recreation sites using a variety of methods, including a cleanup contractor, an inmate crew, District staff, and

through cooperative maintenance agreements with local governments. Most of the improved sites have portable toilets contracted by the District.

The District has a longstanding policy of offering access to its lands for free, largely because of Section 373.1395, Florida Statutes ("Limitation on liability of water management district with respect to areas made available to the public for recreational purposes without charge"). As its title implies, this section provides considerable protection to the District from liability lawsuits resulting from incidents on District Lands, as long as the District does not charge for access or entrance onto or use of the property for recreation purposes.

The management of public recreation areas on District lands is funded through the revenue sources used for general land management activities; namely, revenues derived through timber sales and revenues appropriated by the Legislature for land management purposes.

During the discussion following a presentation at the February 2015 Governing Board meeting, staff was directed to explore the possibility of accepting donations to support the management of recreation areas. In the following months, staff determined that the inclusion of a pay portal on the District's recreation web pages is possible, with payments to be processed through PayPal.

The Governing Board is authorized by Subsection 373.083(4), Florida Statutes, to "Solicit and accept donations or grants of funds or services from both public and private sources for the planning and implementation of district undertakings and delegations, including, but not limited to, projects, programs, works, and studies." Staff is now seeking Governing Board approval to solicit and accept donations of funds to support the management of District recreation areas.

If approval is granted by the Governing Board, District web pages will be revised to include a "Donate Now" button and District email correspondence with those who obtain reservations will include links to the donation application. Individuals making donations will have the ability to direct their donations to a specific Water Management Area if desired.

SUBJECT: Information Item: Consideration of Potential Acquisition of Cypress and Gainer

Springs; Holmes and Econfina Creeks

Following the 2015 Legislative session, the District was appropriated \$4.8 million for the acquisition of properties "that protect the quality and quantity of water that flow from springs." To date, under this appropriation, the District has: 1) acquired the 3.1-acre James Tract on Econfina Creek to enhance protection of Gainer Springs; 2) sought to acquire the 400-acre Blue Springs Plantation, Inc. tract in fee simple; and 3) presented a draft conservation easement to Hancock Farmland Services representatives on the 598-acre Lakeshore Farms II LLC tract. The latter two actions are proposed in order to help restore and protect Jackson-Blue Spring in Jackson County. If one or both of the Jackson-Blue Springs projects are not successful, the available funds can be applied, with DEP approval, to other spring protection projects. The 2016 legislature may also make additional funds available for spring protection efforts.

Outlined below is information on two additional springs that may be available for acquisition; by fee-simple, a less than fee (conservation easement) transaction, or some combination of the two strategies. The first is Cypress Springs, a second magnitude spring (89 mgd) in Washington County. The second is Gainer Springs Group in Bay County, the last first magnitude spring in the state still in private ownership. These potential acquisitions are in an early conceptual stage.

Below is a description of each project's water resource significance, land uses and habitats, proposed conservation easement provisions, including potential public access and recreation benefits and estimated appraisal costs.

# **Cypress Springs**

#### General

Cypress Spring is located approximately 2.5 miles north of Vernon in Washington County (see attached maps). In 2002 and 2003, Nestle Water - North America (Nestle) acquired 40 acres around Cypress Spring and since that time has acquired an additional 268.54 acres surrounding the west and north sides of the spring for a total of 308.54 acres of property. Nestle operates a bulk bottle water pumping facility on the site in proximity to the spring. The water is withdrawn from several wells pumped into tanker trucks and transported to bottling facilities offsite. The District owns and manages 1,114.8 acres east and south of the spring, including almost 80 percent of the land adjacent to the southern spring-run. The spring and spring run are sovereign submerged lands.

A significant number of recreational users access the spring by boat, canoe and kayak from nearby Culpepper Landing, owned and maintained by Washington County. In addition, many individuals access the spring from the District's Cotton Landing recreation site by canoe and by walking down Holmes Creek and wading across the floodplain forest to the spring run. Intensive use by the public has adversely impacted the spring's shoreline, aquatic and floodplain habitats.

# Water Resource Significance

Cypress Spring is a high flowing second magnitude spring with an average recorded discharge rate of almost 58 million gallons per day (89.47 cubic feet per second), first magnitude springs have average flow above 100 cubic feet per second. The spring pool is roughly circular and the main vent measures to a depth of 26 feet. Another spring vent is located 30 feet downstream from the main vent.

#### Land Uses and Habitats

The Cypress Spring property consists of approximately 36 percent wetlands and 64 percent uplands. Approximately one acre of the property consists of sovereign submerged lands associated with Cypress Spring and its spring-run stream. Land uses and habitat types that occur on the property consist of the following:

# **Proposed Conservation Easement Provisions**

As stated previously, details of the possible acquisition are still being developed. What is known at this time is that the acquisition would be a subset of the total 308.54 acres. If the property is acquired, the District will seek DEP springs funding to conduct shoreline restoration and protection measures, provide enhanced public access and other limited recreational facilities, including restroom facilities.

#### **Estimated Appraisal Costs**

Appraisal of the Cypress Springs property is likely to be a difficult appraisal assignment, especially given the lack of recent spring sales and whether there is a combination fee and conservation easement scenario involving the spring shoreline area. Based on these factors, staff estimates appraisal fees at \$10,000 - \$12,000 for two appraisals and \$2,500 - \$3,000 for appraisal review.

#### **Gainer Springs**

#### General

The Gainer Spring Group (Gainer Springs), consisting of at least five known springs, is located one-tenth of a mile south of Highway 20 and two-tenths of a mile west of the junction of Econfina Creek and Highway 20 in northern Bay County (see attached maps). Gainer Springs is owned by Gainer Springs, LLC (Patronis Family) and the springs are a popular recreation stop for canoeists, kayakers and tubers floating down Econfina Creek.

Gainer Springs is a first magnitude spring and, coupled with other springs along Econfina Creek, is the primary source of the Deer Point Lake Reservoir which provides a majority of the drinking water supply for Panama City and surrounding Bay County. The District wishes to acquire property surrounding Gainer Springs to protect this important resource. Recently, Gainer Springs, LLC expressed an interest in selling a conservation easement to the District on all or a portion of its 942-acre ownership.

#### Water Resource Significance

The property contains the western portion of the Gainer Spring Group, which includes Gainer Spring #2 that flows directly into Econfina Creek and Gainer Spring #3 and several smaller springs to the north that encompass a 650-foot long spring-run (USGS). Discharge rates vary for the Gainer Spring Group. Historic measurements for the Gainer Springs Group range from a low of 128.2 cubic feet per second (2002) up to a high of 192.8 cubic feet per second (2004) with an average discharge rate of 160.8 cubic feet per second producing approximately 104 million gallons per day or more of potable water making the Gainer Springs Group an important water resource in northwest Florida.

Public use by canoeists, kayakers and tubers of the adjacent sovereign submerged lands, i.e. Econfina Creek and the spring-run area, along with trespassing on the adjacent uplands and other sensitive habitat areas, have contributed to significant shoreline degradation of Gainer Spring #2. Diving by the public from the slope forest and prolonged visitation in the mixed bottomland forest habitats surrounding the spring's discharge vent have especially degraded the spring's shoreline areas. In addition, public use and stormwater impacts have created erosion and resulted in significant sedimentation of the northern spring-run area.

#### Land Uses and Habitats

The property consists of approximately 14 percent wetlands and 86 percent uplands. Approximately one and one-half acres of the property consists of sovereign submerged lands associated with the Gainer Springs spring-run. Land uses that occur on the property consist of the following:

#### **Habitats**

The property is very biologically diverse with a number of natural habitat types occurring on the property including the following: Sandhill, Upland Hardwood Forest, Mesic Flatwoods, Sinkhole, Limestone Outcrop; Depression Marsh, Alluvial Forest, Seepage Stream, Spring-run Stream and Aquatic and Terrestrial Caves.

#### **Proposed Conservation Easement Provisions**

As stated previously, details of the proposed conservation easement provisions for the Gainer Springs, LLC property are being discussed. What is known is that the Patronis Family desires to permanently protect Gainer Springs and the adjacent property for future generations. Should a conservation easement be acquired, the District will seek DEP springs funding to conduct

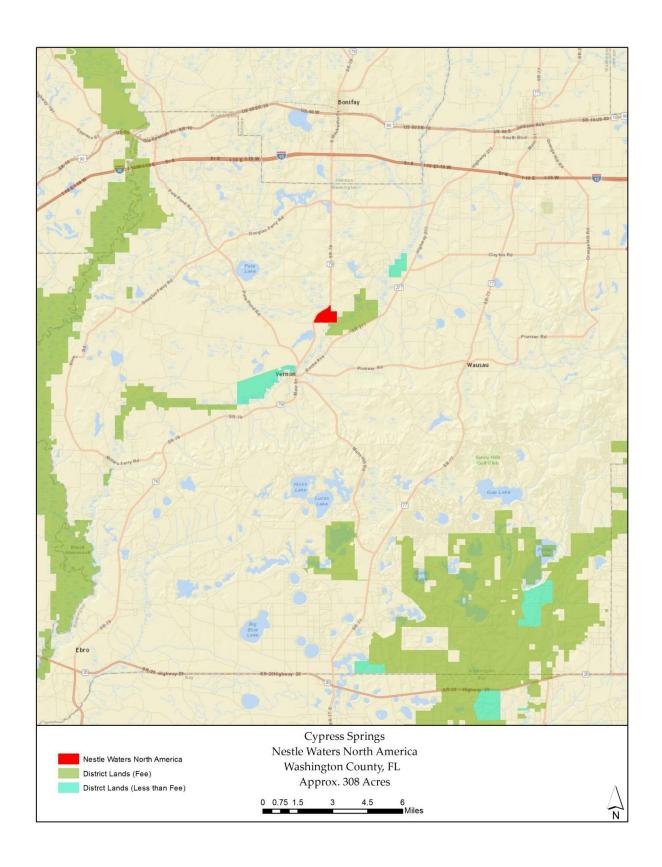
shoreline restoration and protection measures, especially at Gainer Spring #2, and address erosion, stormwater, and sedimentation issues adversely impacting Gainer Spring #3.

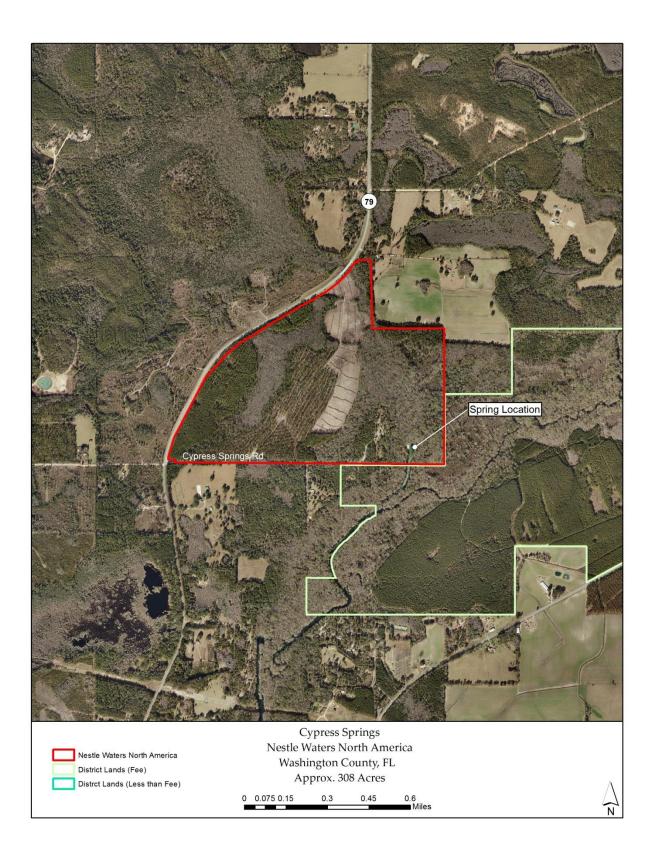
# **Estimated Appraisal Costs**

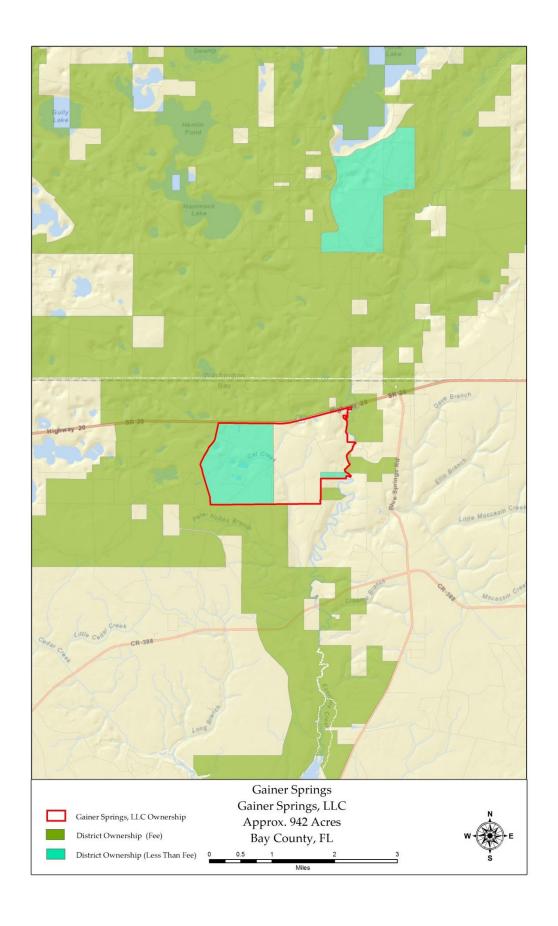
Appraisal of the Gainer Springs, LLC property is also likely to be a difficult appraisal assignment, especially given the lack of recent spring sales, and whether there is a combination fee and conservation easement scenario involving the Gainer Spring shoreline area for spring restoration and protection purposes. Again, based on these factors, staff estimates appraisal fees at \$10,000 - \$12,000 for two appraisals and \$2,500 - \$3,000 for appraisal reviews.

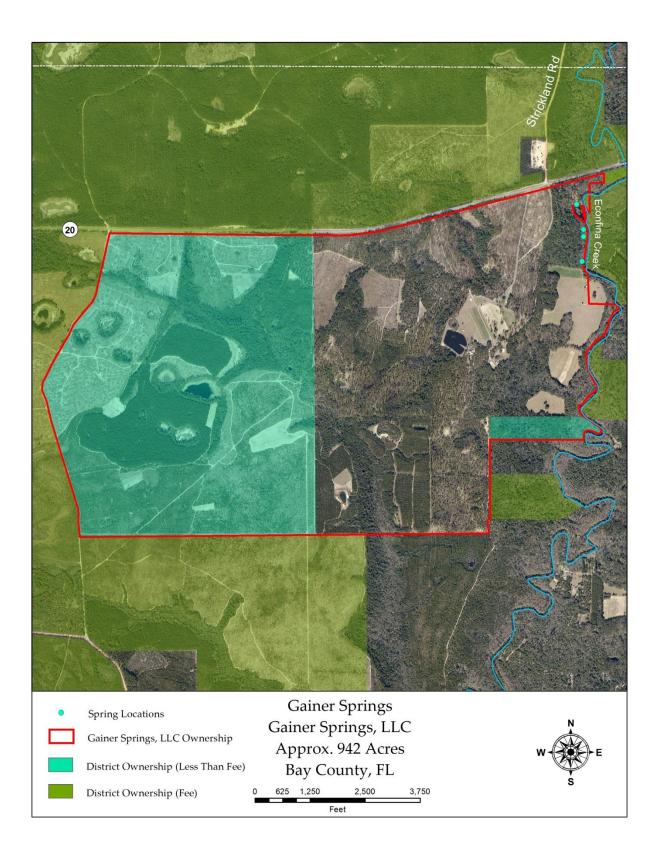
#### **Summary**

Subject to negotiation of the terms and conditions of the conservation easements with Nestle and Gainer Springs, LLC, the District may have an opportunity to protect two significant springs in northwest Florida; one of which is critical to the public water supply of Bay County. Total appraisal costs for the two proposed projects may range from \$25,000 to \$30,000 to value these two valuable water resources. Unless the Committee directs otherwise, staff will proceed with an appraisal of both properties.

SUBJECT: Informational Item - Minimum Flows and Levels Program Update

### **Background**

Section 373.042(1), Florida Statutes, requires each water management district to develop minimum flows and levels (MFLs) for specific water bodies within their jurisdiction. The minimum flow or level for a given waterbody is the limit at which further withdrawals will be significantly harmful to the water resources or ecology of the area. The District's FY 2015 – 2016 MFL Priority List and Schedule is comprised of nine MFL waterbodies, including four first-magnitude springs. As required by statute, the FY 2015–2016 Priority List and Schedule were submitted to the Florida Department of Environmental Protection (FDEP) for approval. FDEP approved the proposed Priority List and Schedule on February 12, 2016.

### **Project Status and Accomplishments**

The District is working concurrently on five MFL water bodies: St. Marks River Rise, Wakulla Spring, Sally Ward Spring, Jackson Blue Spring, and the coastal Floridan Aquifer in Planning Region II (Okaloosa, Santa Rosa, and Walton counties). To date, the District has constructed 15 new monitor wells and instrumented 38 additional surface and groundwater monitoring sites to collect hydrologic and water quality data needed to develop MFLs for the St. Marks River Rise, Wakulla Spring, and Sally Ward Spring system. Specialized water quality data sensors were purchased and installed at seven of these sites to gain a better understanding of the factors contributing to water clarity at Wakulla Spring. During the fall of 2015, ecological and topographic transects were surveyed to characterize floodplain elevations, soils, and vegetation communities along the St. Marks and Wakulla rivers. A conceptual groundwater flow model was developed and work on a numerical groundwater flow model will begin this month. Work will also be initiated during the next few months to develop surface water and estuarine models of the St. Marks and Wakulla river system.

During the past year, staff has met with stakeholders including the City of Tallahassee and the Wakulla Alliance to provide them with an overview and status of the MFL development process.

The technical assessments for the St. Marks River Rise are on schedule to be completed in 2018, with the technical assessments for Wakulla Spring and Sally Ward Spring completed in 2020.

In 2015, a work plan was prepared for the development of MFLs for the coastal Floridan aquifer in Planning Region II. The work plan describes data collection needs, the technical approach, and project schedule and budget. The District has contracted with a consultant team to expand and recalibrate a regional groundwater flow model that encompasses the study area. The District recently issued an Invitation to Bid for exploratory testing and construction of up to six deep coastal Floridan aquifer monitor wells. Thirteen additional existing wells were assessed to determine their suitability for water quality monitoring. Enhanced water quality monitoring will begin later this year and analyses of long-term trends in groundwater quality will be performed. During the past month, staff provided an overview of our MFL program to the Regional Utilities Authority and the Northwest Florida Utility Managers Council. The project is on schedule, with the technical assessments to be completed in 2020.

The Jackson Blue Spring MFL project was initiated in 2014, two years earlier than initially scheduled. A work plan that outlines a detailed scope of work and schedule for the technical assessment was completed in 2015. Enhanced surface water monitoring of the spring system and Merritt's Mill Pond has been initiated. Four new monitor well sites were selected and access has been obtained from property owners. Near Jackson Blue Spring, a 450-foot deep core is being installed by the Florida Geological Survey to gain a better understanding of the hydrogeologic and aquifer properties near the spring vent. Following the coring, monitor wells will be constructed and instrumented to monitor aquifer levels. The data collected will be used to develop and calibrate a groundwater flow model of the Jackson Blue Spring contribution area. Ecological, topographic, and floodplain transect data will be collected later this year along Merritt's Mill Pond and Spring Creek to support the future development of surface water and ecological models. The project is on schedule, with the technical assessments to be completed in 2022.

Okaloosa County has indicated that it plans to develop a new water supply on the Shoal River. As a result, the District accelerated the schedule for the Shoal and Yellow River MFL Project by three years, with MFL initiation now scheduled for 2017. Later this year, staff will begin developing a work plan that outlines data collection, technical assessments, schedule, and estimated budget needed to develop the MFL for the Shoal and Lower Yellow River system.

**Restoration Projects** 

### **Background**

Protecting and restoring northwest Florida's springs and their associated ecosystems and public benefits is a continuing priority for the District. Current activities include restoration and protection projects at Devil's Hole Spring on Econfina Creek (Econfina Creek Water Management Area) and Cotton Landing along the Holmes Creek spring run (Choctawhatchee River and Holmes Creek Water Management Area). There are also two projects within the Jackson Blue Spring/Merritt's Mill Pond basin in Jackson County. They include extending central sewer service to the lower Indian Springs subdivision and helping farmers implement agricultural best management practices (BMPs) for water conservation and water quality improvement within the Jackson Blue Spring contribution area. Within the Wakulla Springs system, the District has also initiated efforts to assist Wakulla and Leon counties with sewer line extensions and elimination of septic systems.

The Florida Legislature has made it a priority to protect Florida's springs and funded these projects through legislative appropriations to the Department of Environmental Protection (DEP). DEP has partnered with the District and funded the aforementioned springs restoration and protection activities. All of these activities are focused on advancing the strategic priority established within the Strategic Water Management Plan (SWMP) to protect and restore water quality and flows within the major spring systems of northwest Florida. Many of the restoration projects also enhance public access in a manner that is consistent with protecting the unique aquatic, riparian, and wetland ecosystems supported by Florida's springs.

#### FY 2016-2017

Staff will present a preliminary set of potential projects under consideration for fiscal year 2016-2017 funding. Among these are additional septic tank to central sewer projects, spring/creek habitat protection and restoration activities, expansion of the agricultural BMP producer cost-share program, and less-than-fee land acquisition and protection. We anticipate presenting the final list of proposed springs protection and restoration projects, including funding recommendations, to the Governing Board for approval later in the year.
