SUBJECT: Consideration of Confidentiality Agreement with Jackson County for the Peacock

Bridge Tract

Recommendation:

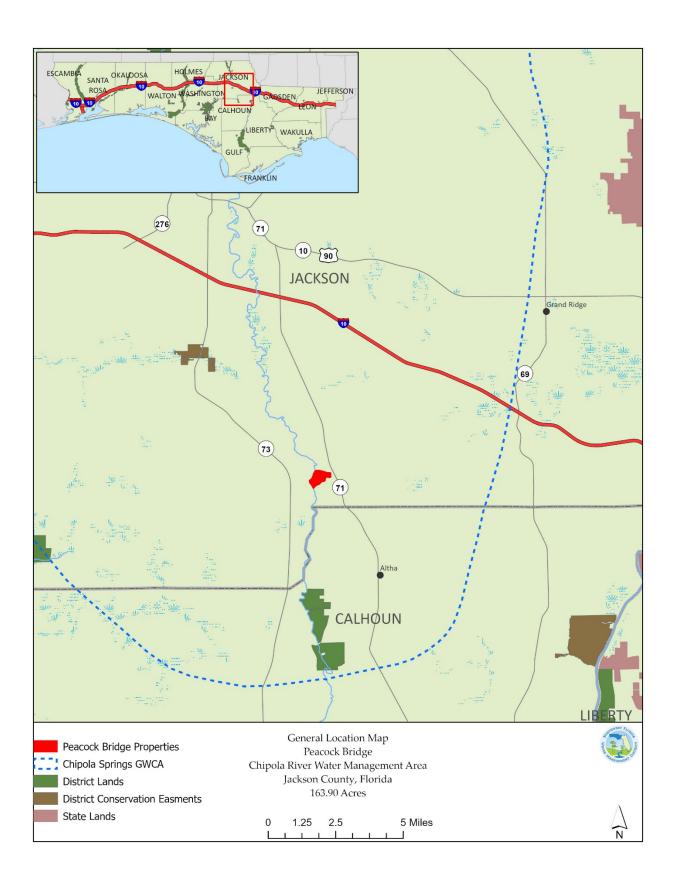
Staff recommends the Governing Board authorize the Executive Director to execute the Confidentiality Agreement between the District and Jackson County for the Peacock Bridge tract.

Background:

The owners of the Peacock Bridge tract approached the District about purchasing the fee simple interest. The tract is approximately 163.9 acres (see attached maps) and is located off Peacock Bridge Road in Jackson County. The tract contains a boat ramp and parking lot, is bound by the Chipola River on the west side, by Sink Creek on the south side, and is located within the Chipola Springs Groundwater Contribution Area.

The District is seeking Governing Board approval to enter into an agreement with Jackson County that would allow the District to share the appraisals prepared on this tract. Section 373.139(3)(a), Florida Statutes, allows the District to disclose appraisal information, offers, and counter-offers to a third party who has entered into a contractual agreement with the District to work with, or on the behalf of, or to assist the District in connection with land acquisitions. In this instance, the District desires to share appraisals on this tract to discuss funding availability from Jackson County to put toward the purchase price for the Peacock Bridge tract.

Jackson County has an agreement with the current landowners to manage the boat ramp located on this tract and supports the District's acquisition of this tract to maintain public access to this boat ramp. By entering into this agreement, the District can share its appraisals of the tract and complete its negotiations on the purchase price with the landowners. If negotiations are successful, an agreement to purchase the tract would be presented at the next regularly scheduled board meeting.





CONFIDENTIALITY AGREEMENT BETWEEN NORTHWEST FLORIDA WATER MANAGEMENT DISTRICT AND JACKSON COUNTY, FLORIDA FOR PEACOCK BRIDGE TRACT - JACKSON COUNTY, FLORIDA

THIS AGREEMENT is entered into between Jackson County, Florida, acting through its duly elected Board of County Commissioners, ("Cooperating Entity"), and the Northwest Florida Water Management District ("District"), as follows:

1. **Confidentiality**. As required by the provisions of Section 373.139(3)(a) Florida Statutes, the District and Cooperating Entity, on their own behalf and on behalf of their respective employees and agents, shall maintain the confidentiality of all appraisals, offers and other negotiation matters for the Peacock Bridge tract in Jackson County, Florida.

Cooperating Entity and District may disclose appraisal information to the general public only when an option contract is executed or, if no option contract is executed, 30 days before a contract or agreement for purchase is considered for approval by the District's Governing Board. If a contract for the purchase of the Parcel is not consummated, then, as provided in section 119.07(1), F. S., the District will determine when the passage of time has rendered the conclusions of value in the report invalid, and the District will provide written authorization to the Cooperating Entity to release the appraisals. The District may require as a condition of recommending approval of a purchase instrument by the District's Governing Board, a certification that the Cooperating Entity has maintained the confidentiality of the appraisals, offers and counteroffers, and other negotiation matters. This certification shall be in the form of a letter signed by legal counsel for the Cooperating Entity.

Cooperating Entity understands and agrees that all documents, papers, letters, maps and other materials (the "records") specifically relating to the acquisition of the Parcel will become a public record as defined in Chapter 119, F. S., when an option contract is executed or, if no option contract is executed, 30 days before a contract or agreement for purchase is considered for approval by the District's Governing Board. At that time all records of the Cooperating Entity relating to the acquisition shall become public record and shall be subject to public access in the same manner as are other public records under the provisions of chapter 119, F. S. This Agreement may be terminated by the District if the Cooperating Entity fails to allow public access to any such records.

2. **Parcel.** The Parcel is known as the Peacock Bridge tract located in Jackson County, and is located within the Chipola River Springs Groundwater Contribution Area (the "Project"). The term "Parcel" as used herein shall mean and refer to the parcel shown on Exhibit "A".

SUBJECT: National Fish and Wildlife Foundation Emergency Coastal Resilience Fund Grants

The National Fish and Wildlife Foundation (NFWF) announced the availability of approximately \$24 million nationally through the Emergency Coastal Resilience Fund (ECRF). The purpose of the program is to create and restore natural systems to help protect coastal communities from disasters and threats such as coastal storms, floods, sea-level rise, inundation, and coastal erosion, and to enable communities to recover more quickly from these events. To do this, the program will prioritize nature-based projects that provide benefits for community resilience and for fish and wildlife. Eligible applicants include state and local governments, non-profit organizations, educational institutions, and for-profit entities. Proposed projects must, however, be within areas that received a federal Major Disaster Declaration with a Public Assistance designation as a result of hurricanes or wildfires in 2020 and 2021. This includes nearly all of northwest Florida, with exceptions including Leon and Wakulla counties and portions of Jackson, Calhoun, and Okaloosa counties. Grant proposals are due February 3, 2022.

District staff are working closely with local governments and stakeholders to identify and develop strategies and projects that will improve long-term resilience for our communities and natural systems. It is expected that most proposals will be submitted by local governments directly, as they own and operate any affected facilities and will be responsible for long-term maintenance of the developed green infrastructure. District staff, however, will continue to work with them to develop strategies and project concepts and to assist in implementation and monitoring. Some examples include living shorelines projects to restore littoral estuarine habitats while protecting shorelines and critical infrastructure, regional stormwater facilities that improve water quality and flood protection, and wetland restoration projects to restore and enhance wetland functions.

District staff are also developing conceptual projects that may be submitted for funding. These include hydrologic analysis and conceptual stormwater planning to assist the City of Port St. Joe and Gulf County. This is significant given the complexity of regional hydrology and the importance of downstream receiving waters. Additionally, detailed stream surveys may be conducted to map remaining stream reaches in impacted by storm debris and to support modeling of floodplain impacts and the potential for improved flood protection. District staff will present an overview of potential projects during the January 13, 2022, Governing Board meeting.

Northwest Florida Water Management District, Petitioner, vs. GHD Construction Services, Inc., Defendant, Walton County Circuit Court Case No. 21CA137

The District has filed and served a Petition for Enforcement against GHD Construction Services, Inc. ("GHD"), stemming from GHD's violation of a Consent Order and of District statutes and rules. The District is seeking an injunction against GHD to require its compliance with the Consent Order and to cease violating statutes and rules. The District is also seeking the statutory monetary penalties associated with such violations.

GHD is the holder of an environmental resource permit known as a "10/2 Self-Certification" for the development and construction of residential units in DeFuniak Springs. In February 2020, the District determined that GHD was not complying with its permit and was violating District statutes and rules by adversely impacting wetlands. The District and GHD entered into a Consent Order in February 2020, whereby GHD agreed to pay a penalty and remediate the impacted wetlands. GHD eventually paid the penalty, but it never began the required remediation. After many failed attempts to motivate GHD to perform the required mediation, the District was forced to file the Petition for Enforcement.

The District has served discovery requests upon GHD and responses have been received. The responses and documents have been reviewed and do not change the District's analysis of the case. The Deposition of GHD's corporate representative is schedule for January 26, 2022. The District's motion to recover fees from GHD's prior default has been heard. The Judge reversed his prior intention to award fees against a prevailing party and noted the District, if it ultimately prevails, would still be entitled to recover those fees at the conclusion of the case and/or may otherwise readdress the issue at a later date. At the January 4, 2022, hearing the trial date was addressed and the Judge informed the parties that a separate Case Management Conference must be held to schedule trial. This should be scheduled by the time of the meeting.
