### Recommendation

Staff recommends the Governing Board approve extending the grant agreement for the Okaloosa County/Eglin AFB/Niceville Reclaimed Water Project to June 30, 2023.

### Discussion

In 2019, the Governing Board authorized the Executive Director to enter into agreement with the Department of Environmental Protection and the cooperator, Okaloosa County, for \$2,500,000 in state alternative water supply grant funding for construction of an alternative water supply development project within the District's Region II water supply planning region. In cooperation with Eglin AFB and the city of Niceville, Okaloosa County is installing approximately 11 miles of wastewater reuse line from the Arbennie Pritchett Water Reclamation Facility to the city of Niceville, with a service lateral for future use to Eglin AFB. In addition to the state alternative water supply funding, the project is funded by a direct state appropriation of \$3,000,000 and more than \$2,500,000 of county funds.

The project is well underway, with construction approximately 20 percent complete. As construction has proceeded, Okaloosa County has experienced labor and material supply shortages which have delayed final completion of the project. Given this, the county has requested the District extend the associated grant agreement to June 30, 2023. With the Governing Board's approval, the District will extend the project grant agreement and the associated grant agreement from the Department of Environmental Protection.

### Recommendation

Staff recommends the Governing Board authorize the Executive Director to enter into agreement with the Florida Department of Environmental Protection to accept up to \$1,085,392.62 in grant funding for the completion of Apalachicola Bay water quality improvement projects.

### Discussion

In February 2017 and March 2018, the Governing Board authorized the District to approve funding for the City of Carrabelle and the City of Apalachicola, respectively, to implement water quality improvement projects. For the City of Carrabelle, this includes funding for Phase 1 of the Lighthouse Estates septic to sewer project. For the City of Apalachicola, this provided for funding to complete stormwater retrofit activities to improve the quality of runoff discharging into Apalachicola Bay. Funding was provided through the use of Governing Board resolutions to the Florida Department of Environmental Protection (DEP) to allow the District to invoice DEP for funding provided from the Water Management Lands Trust Fund.

This past year, DEP determined the remaining funding needed for the projects must be authorized through a separate grant agreement between the Department and the District, rather than relying on past Board resolutions.

### **Recommendation:**

Staff recommends the Governing Board approve the agreement and authorize the Executive Director to execute the agreement with Liberty County for the Beaverdam Recreation Site.

### **Background:**

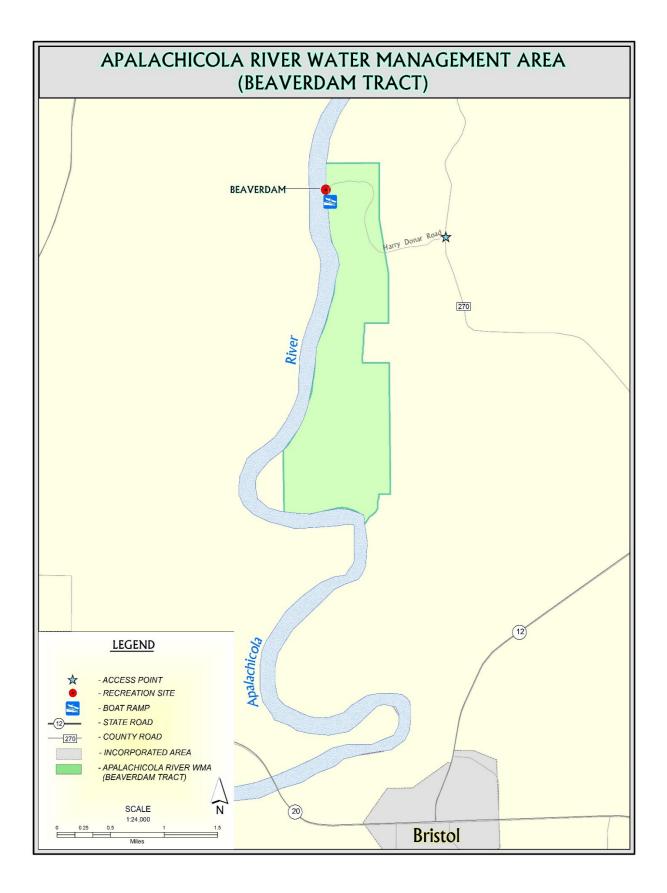
The District acquired the Beaverdam tract in Liberty County in 2011. The 1,316.70-acre property was purchased utilizing funding from Florida Forever and the District General Fund. The tract was acquired for the purpose of protecting the water resources of the Apalachicola River.

The Beaverdam tract provides recreational opportunities and access to the Apalachicola River via the Beaverdam Boat Ramp. This public boat ramp is one of four public boat ramps on the eastern side of the river from Lake Seminole to Highway 20.

An agreement between the District and Liberty County has been drafted to identify responsibilities of each party throughout the life of the project. The agreement is perpetual unless terminated by either party. In summary, Liberty County will be responsible for the following:

- a. Maintain Harry Donor Road, including removal of tires and debris located along Harry Donor Road.
- b. Maintain the parking area and existing boat ramp. Liberty County will apply for the Florida Boating Improvement Program to improve the boat ramp on the Beaverdam tract.
- c. Remove trash from the boat ramp and parking area (at the end of Harry Donor Road) at least once a week.
- d. Purchase and install an informational kiosk and picnic pavilion.
- e. Install a concrete slab and pay for the service of one handicap portable toilet.

The District will be responsible for providing a sign to be placed in the parking area.

Staff recommends the Governing Board approve Amendment No. 1 and authorize the Executive Director to execute Amendment No. 1, subject to legal counsel review.

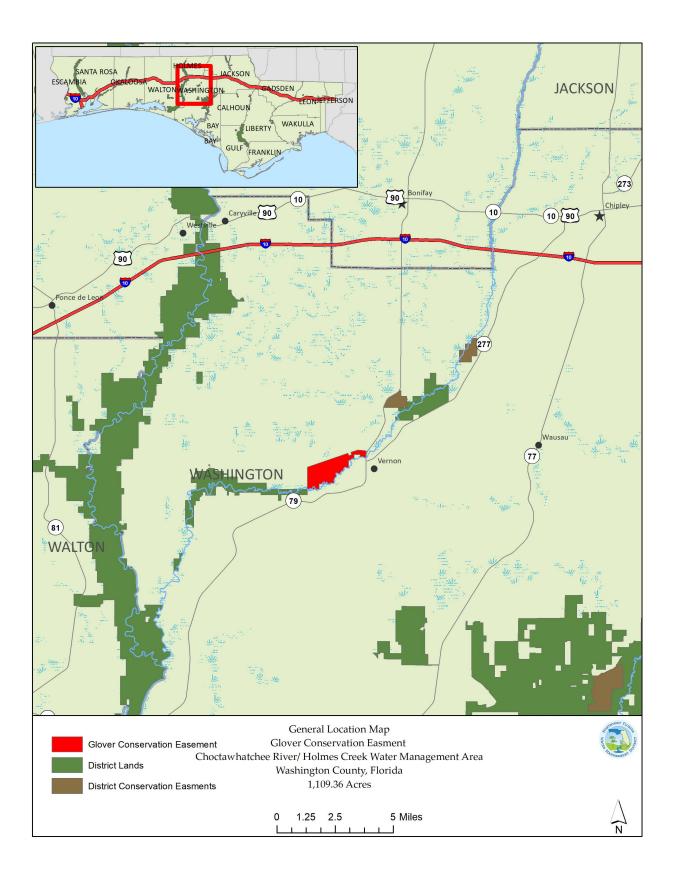
### Background:

In August 2001, the District purchased a conservation easement on 1,109.36 acres from the Glover family for \$600,000 with Preservation 2000 funds. The property is located on Creek Road, West of Highway 79 in Washington County (see attached map).

The Glover conservation easement was one of the earlier easements negotiated and executed by the District and did not allow for any impervious surface for residential purposes. The easement only allows impervious surface, in the amount of 43,560 square feet, for domestic livestock production uses and practices. Over the last 20 years, the District's conservation easements have seen significant change and almost all conservation easements now include impervious surface for residential purposes.

The Glover family has requested an amendment to the conservation easement. The family would like to amend the conservation easement to allow 5,000 square feet of impervious surface to be used for residential purposes and reduce the square footage allowed for domestic livestock uses to 38,560 square feet. As of the District's last compliance inspection on June 29, 2021, a total of 22,482 square feet of impervious surface was being utilized for domestic livestock production uses and practices. In addition to amending for the use of 5,000 square feet of impervious surface for residential purposes, this amendment would also include language that no additional septic tanks can be installed at any of the three existing residences.

Resource Management staff conducted a desktop analysis on allowing 5,000 of the 43,560 square feet of impervious surface to be utilized for residential purposes and concluded the proposed change is not anticipated to have a negative impact on the water resource values of the property. This amendment will rectify the impervious surface needed for an existing prohibited structure (carport containing 602 square feet) and also allow the Glover family to add impervious surface at any of the three existing residences on the property without concerns for future violations of the District conservation easement.

### DESCRIPTION:

Florida Department of Corrections (DOC) requests renewal of Individual Water Use Permit (IWUP) No. 2B-037-5655 for the continued authorization of groundwater withdrawals from the Floridan aquifer for institutional use without changes to the currently permitted withdrawal amounts.

DOC utilizes groundwater for heating and cooling use and minor agricultural irrigation use at the Franklin Correctional Institution. The facility has a capacity of 1,350 people and irrigation need for 17 acres of small vegetables. Staff used the Agricultural Field Scale Irrigation Requirements Simulation (AFSIRS) to determine the irrigation demand associated with 17 acres of spring and fall planted small vegetables. Staff recommends continued authorization of the withdrawals which includes the AFSIRS derived irrigation amounts and the heating and cooling amounts. These amounts are considered reasonable and adequate to meet the applicant's water use demands for the recommended permit duration.

The system is a single pass closed loop system and, therefore, practically 100% of groundwater withdrawn for heating and cooling is returned to the same aquifer system. District staff used the program DRAWDOWN to analyze potential impacts to the Floridan aquifer associated with the minor agricultural irrigation over the 20-year permit period. The simulated drawdowns in the Floridan aquifer were less than one foot at distances of one-half mile and one mile from the center of pumping. These drawdowns are not anticipated to interfere with existing legal uses.

#### PERMIT APPLICATION REVIEW:

Section 373.223, Florida Statutes (F.S.), and section 40A-2.301, Florida Administrative Code (F.A.C.), require an applicant to establish that the proposed use of water:

- (a) Is a reasonable-beneficial use;
- (b) Will not interfere with any presently existing legal use of water; and,
- (c) Is consistent with the public interest.

In addition, the above requirements are detailed further in the District's Water Use Permit Applicant's Handbook. District staff have reviewed the water use permit application pursuant to the above-described requirements and have determined that the application meets the conditions for issuance of this permit.

### **RECOMMENDATION:**

It is the determination of the staff that the water use amounts recommended, as conditioned, are reasonable-beneficial, consistent with the public's interest, and will not interfere with any presently existing legal use of water. This determination has been made according to provisions of Chapter 373, F.S., and Chapter 40A-2, F.A.C.

Staff recommends that the applicant be granted an Individual Water Use Permit for an annual average daily withdrawal of 1.6 million gallons; and a maximum monthly withdrawal of 49.6 million gallons. Staff also recommends that the expiration date of the permit be April 1, 2042, and that the permit be conditioned as per the "Conditions for Issuance" included in Exhibit A of the permit document.

- 1. This permit shall expire on April 1, 2042.
- 2. This Permit authorizes the Permittee to make an average annual withdrawal of 1.6 million gallons per day (49.6 million gallons per month maximum) of groundwater from the Floridan aquifer for institutional use. The individual facilities authorized to make this combined withdrawal are shown in the table below in the following condition. - 4. The Permittee shall include the Individual Water Use Permit number and the well's Florida Unique Identification Number (e.g. AAR0800 for FCI #1R) when submitting reports or otherwise corresponding with the District.
- 5. The Permittee shall limit groundwater used for agricultural irrigation to an average annual withdrawal of 0.0214 million gallons per day (1.59 million gallons per month maximum).
- 6. The Permittee, by January 31 of each year, shall submit a water use report of total water usage for agricultural irrigation for the previous calendar year (January December), even if no water is used. The Permittee shall record the data required on Water Use/Pumpage Report Form (Form 166). The Permittee, if preferred, may submit the report electronically by downloading the correct form from the District website, filling it out properly, and e-mailing it to compliance@nwfwater.com. The next report is due by January 31, 2023.
- 7. The Permittee, by January 31 of each year, shall submit a status report using Form 168, Annual Crop Summary Report Form. The report shall include: type and acreage of crop(s) planted and irrigated; type(s) of irrigation system(s); and the number of livestock being watered.
- 8. The Permittee, by January 31 of each year, shall submit a statement certifying that nominally 100 percent of water withdrawn for heat pump supply use was returned to the same portion of aquifer from which it was withdrawn. If there is any discharge of water from the heating and cooling system (i.e. not returned to the aquifer) greater than 0.1 million gallons in a single occurrence, the Permittee, within 30 days of the discharge event, shall record the data required on Water Use Summary Reporting Form (Form 172). The Permittee shall provide an explanation for the discharge of water from the heating and cooling system, and describe corrective actions to be taken. The Permittee, if preferred, may submit the report electronically by downloading the correct form from the District website, filling it out properly, and e-mailing it to compliance@nwfwater.com.
- 9. The Permittee shall maintain, in working order, in-line totalizing flow meters at the well heads on all withdrawal wells (FCI #1R, FCI #2R, FCI #3R, FCI #4, FCI #5, FCI #6, FCI #7, FCI #8, FCI #9, FCI #10, FCI #11, and FCI #12). The meters shall be maintained to be at least 95% accurate and any meter determined defective must be replaced within 30 days of its discovery. The Permittee, within 30 days of meter installation, shall provide documentation to the District that the required flow meters have been installed and report the initial meter readings.
- 10. The Permittee, by October 31, in years 2024, 2029, 2034, 2039, and at the time of requesting a permit modification or renewal, shall submit documentation of the flow meter calibration and accuracy ratings for all flow meters to the District using the Flow Meter Accuracy Report Form (Form 170). The Permittee, if preferred, may submit the report electronically by downloading the correct form from the District website, filling it out properly, and e-mailing it to <u>compliance@nwfwater.com</u>.
- 11. The Permittee shall submit to the District in a single electronic submittal the following information by January 31, April 30, July 31 and October 31 of each year:

Static water level measurements for Floridan aquifer well FCI #1R conducted during the first two weeks of each month for the previous three months (e.g. measurements for January, February,

and March shall be submitted by April 30) using a District-approved water level measuring device. Water levels shall be taken following a 24-hour non-pumping period, as much as is practicable, reported as depth-to-water below a pre-defined measuring point. All measurements shall be taken from the same measuring point. If the measuring point is different from land surface elevation, then the Permittee shall provide the measuring point distance above or below land surface. All static water level reports shall include the date and time the well was turned off, date and time the measurement was taken, method and device used, and the water level measurement to 0.01 foot for steel/electric tape and 1.0 foot precision for airline methods, respectively. The Permittee, if utilizing the airline method, shall also report airline length, gauge reading, linear distance of the airline terminus from land surface, and a description of where the airline terminates (e.g. land surface, pump base, pressure gauge, etc.).

- 12. The Permittee shall collect water quality samples for laboratory analyses from FCI #1R within the first two weeks of January and July in each year. Prior to sampling, the Permittee shall purge a minimum of three well volumes and report, with each set of test results: the duration of purging, purge volume, and purge rates used. All sampling and analysis methodologies used shall conform to standards established in Chapter 62-160, F.A.C., Quality Assurance. Furthermore, all water quality analysis shall be conducted by a laboratory with National Environmental Laboratory Accreditation Program (NELAP) and Florida Department of Health Rule 64E-1, F.A.C., certification for the constituents of concern. The water quality analyses shall include the following constituents: chloride, sodium, total dissolved solids. The Permittee shall submit results from tests conducted in January and July to the District by February 28 and August 31 of each year. At the time of modification or renewal, the Permittee shall submit a summary and analysis of the water quality data collected for the wells for the entire period of record.
- 13. The Permittee shall maintain well FCI #1 Carrabelle (AAF8224) in such condition that the City of Carrabelle can access it for withdrawal and monitoring purposes.
- 14. Heat Pump Supply Uses The Permittee shall return nominally 100% of water withdrawn for Heat Pump Supply to the same portion of the aquifer from which it was withdrawn.
- 15. The Permittee shall encourage and provide for the efficient and non-wasteful use of water, and shall implement water conservation measures, including a proactive leak detection program, designed to enhance water use efficiency and reduce water demand and water losses.
- 16. The Permittee shall maximize the use of reclaimed water if it is available and its use is environmentally, economically and technically feasible.
- 17. The Permittee shall maximize the use of surface water and/or stormwater for agricultural irrigation prior to the use of the Floridan aquifer wells for agricultural irrigation.
- 18. The Permittee, prior to the construction, alteration and/or enhancement of any surface water withdrawal, diversion, or management system, shall contact the District to determine if a permit will be required. A permit would be required by the District for activities including creek sandbagging, sump excavation, and any maintenance beyond that considered routine or custodial.

- 19. The Permittee shall annually evaluate the efficiency of each of its irrigation units and undertake necessary maintenance, repairs and upgrades to provide for the proper efficiency of its equipment. The Permittee shall maintain and repair the irrigation system to avoid the inefficient use of or loss of water through pipe leaks, broken sprinkler heads, and clogged emitters. The Permittee shall maintain the irrigation system to prevent wasteful runoff from the property associated with irrigation.
- 20. The Permittee shall equip the well and irrigation system with an anti-siphoning device if chemicals are to be applied through the irrigation system, as required by section 487.064, F.S.
- 21. The Permittee shall ensure that any new irrigation system(s) purchased is/are of an efficiency rating of 90% or greater.

### **Standard Conditions**

- 22. All water uses authorized by this permit shall be implemented as conditioned by this permit, including any documents incorporated by reference in a permit condition. The District may revoke this permit, in whole or in part, or take enforcement action, pursuant to sections 373.136 or 373.243, F.S., unless a permit modification has been obtained to address the noncompliance.
- 23. The Permittee shall immediately notify the District in writing of any previously submitted information that is later discovered to be inaccurate.
- 24. This permit does not convey to the Permittee any property rights or privileges other than those specified herein, nor relieve the Permittee from complying with any applicable local government, state, or federal law, rule, or ordinance.
- 25. The Permittee shall notify the District in writing within 45 days of any sale, transfer, or conveyance of ownership or any other loss of permitted legal control of the project and/or related facilities from which the permitted water use is made. Where Permittee's control of the land subject to the permit was demonstrated through a lease, the Permittee must either submit documentation showing that it continues to have legal control or transfer control of the permitted system/project to the new landowner or new lessee. All transfers of ownership are subject to the requirements of section 40A-2.351, F.A.C. Alternatively, the Permittee may surrender the water use permit to the District, thereby relinquishing the right to conduct any activities under the permit.
- 26. Nothing in this permit should be construed to limit the authority of the District to declare a water shortage and issue orders pursuant to Chapter 373, F.S. In the event of a declared water shortage, the Permittee must adhere to the water shortage restrictions, as specified by the District. The Permittee is advised that during a water shortage, reports shall be submitted as required by District rule or order.
- 27. With advance notice to the Permittee, District staff with proper identification shall have permission to enter, inspect, observe, collect samples, and take measurements of permitted facilities to determine compliance with the permit conditions and permitted plans and specifications. The Permittee shall either accompany District staff onto the property or make provision for access onto the property.

- 28. The Permittee may seek modification of any term of an unexpired permit. The Permittee is advised that section 373.239, F.S., and section 40A-2.331, F.A.C., are applicable to permit modifications.
- 29. The District reserves the right to curtail permitted withdrawal and diversion rates if the withdrawal or diversion causes harm to legal uses of water, offsite land use, or water resources and associated environmental features that existed at the time of permit application.
- 30. The Permittee shall not cause harmful saltwater intrusion. The District reserves the right to curtail permitted withdrawal rates if withdrawals cause harmful saline water intrusion.
- 31. The Permittee's consumptive use of water as authorized by this permit shall not reduce a flow or level below any minimum flow or level established by the District or the Department of Environmental Protection pursuant to sections 373.042 and 373.0421, F.S. If the Permittee's use of water causes or contributes to such a reduction, then the District shall modify or revoke the permit, in whole or in part, unless the Permittee implements all provisions applicable to the Permittee's use in a District-approved recovery or prevention strategy.
- 32. The Permittee shall mitigate any harm caused by withdrawals or diversions permitted herein on legal water uses, offsite land use, and water resources and associated environmental features which existed at the time of permit application. Mitigation may include modification of the Permittee's pumping schedule (i.e., duration, withdrawal rates, time of day, etc.), the lowering of the affected pump(s) or the replacement of the well(s) including proper plugging and abandonment of the well(s) that is replaced. The Permittee, upon receipt of an allegation of interference, shall retain the services of an appropriate licensed professional to investigate the alleged interference. The Permittee shall ensure their chosen professional investigates any alleged interference within 48 hours of the allegation being made and provides the conclusions of the investigation to the entity alleging the impact within 72 hours of the allegation being made. If it is determined that the use of a well has been impaired as a result of the Permittee's operation, the Permittee shall complete the required mitigation within 30 days. The Permittee shall be responsible for the payment of services rendered by the licensed professional. The Permittee, within 30 days of any allegation of interference, shall submit a report to the District including the date of the allegation, the name and contact information of the party making the allegation, the result of the investigation made, and any mitigation action undertaken.

# Northwest Florida Water Management District, Petitioner, vs. GHD Construction Services, Inc., Defendant, Walton County Circuit Court Case No. 21CA137

The District has filed and served a Petition for Enforcement against GHD Construction Services, Inc. ("GHD"), stemming from GHD's violation of a Consent Order and of District statutes and rules. The District is seeking an injunction against GHD to require its compliance with the Consent Order and to cease violating statutes and rules. The District is also seeking the statutory monetary penalties associated with such violations.

GHD is the holder of an environmental resource permit known as a "10/2 Self-Certification" for the development and construction of residential units in DeFuniak Springs. In February 2020, the District determined that GHD was not complying with its permit and was violating District statutes and rules by adversely impacting wetlands. The District and GHD entered into a Consent Order in February 2020, whereby GHD agreed to pay a penalty and remediate the impacted wetlands. GHD eventually paid the penalty, but it never began the required remediation. After many failed attempts to motivate GHD to perform the required remediation, the District was forced to file the Petition for Enforcement in April 2021.

The District has served discovery requests upon GHD and responses have been received. The responses and documents have been reviewed and do not change the District's analysis of the case. The deposition of GHD's corporate representative was taken on January 26, 2022, and the testimony received does not change the District's analysis of the case. A case management conference was held on February 22, 2022. The Court indicated that it would order mediation but it has not been set yet. The Court has set the trial for August 9, 2022.

We continue to litigate this case as expeditiously as possible and remain confident in our position.
